### Santa Rosa Cumulative Drought Reductions



- In March, Santa Rosa residents reduced water use by 10% in compared to 2020
- From July 2021 March 2022, water use has been reduced by 20% compared to 2020

## Governor Newsom's March 28 Executive Order

On March 28, 2022, Governor Newsom issued Executive Order 7-77 directing the State Water Resources Control Board to consider adopting emergency regulations that:

- Require Urban Water Suppliers submit a preliminary Annual Water Supply and Demand Assessment by June 1, 2022
- Require all Urban Water Suppliers institute shortage plan stage consistent with up to 20% conservation
- Define "non-functional turf" and ban irrigation of these areas in Commercial, Institutional, and Irrigation customer class

## Governor Newsom's March 28 Executive Order

#### March 28, 2022, Executive Order 7-77 also includes:

- Streamlined permitting of GW recharge projects
- Requires consultation with GSAs for new private well permits > 2 Acre-feet per year
- Emergency Water Hauling Provisions
- Illegal Diversion Enforcement Inspection
- Expedited agency approvals for fish & wildlife protection actions related to drought

## Russian River Curtailments - 2022

- SWRCB Hosted workshop on April 14<sup>th</sup>:
- Temporary curtailments suspended into May, likely to readopt emergency regulations
- Curtailment Notices went out in March to ~2500 water right holders in Russian River Watershed
- Revised Water Availability Analysis / Projections
- Proposed Implementation of Voluntary Water User Agreements
- May 10, 2022 Proposed adoption of revised Russian River emergency regulations
- Sonoma Water deliveries to retailers will be governed by TUCO
