RESOLUTION OF THE COUNCIL OF THE CITY OF SANTA ROSA APPROVAL AND ISSUANCE OF A PURCHASE ORDER TO VAC-CON, INC. FOR THE PURCHASE OF TWO VAC-CON COMBINATION SEWER AND STORM DRAIN CLEANERS AND ONE HYDRO-EXCAVATOR UNDER SOURCEWELL COOPERATIVE AGREEMENT NUMBER 101221-VAC

WHEREAS, the Transportation and Public Works Department (TPW) submitted a request to purchase two Vac-Con Combination Sewer Cleaners and one Vac-Con Hydro Excavator under the Sourcewell Cooperative Agreement Number 101221-VAC; and

WHEREAS, the equipment will be used by the TPW and Water Departments; and

WHEREAS, TPW has obtained quotes for the Vac-Con, Inc. equipment from Municipal Maintenance Equipment, Inc., Sacramento, California for the equipment below for a total amount of \$1,677,873.59

- Vac-Con Model VPD4211HE/1300 Combination Sewer and Storm Drain Cleaner with lateral kit mounted on a new Freightliner Model 114SD 6x4 truck chassis in the amount of \$573,140.82
- Vac-Con Model VPD4211HE/1300 Combination Sewer and Storm Drain Cleaner with excavation kit mounted on a new Freightliner Model 114SD 6x4 truck chassis in the amount of \$573,911.03
- Vac-Con Model VXP4212LHE/1100 Hydro Excavator with mounted boom on a new Freightliner Model 114SD 6x4 truck chassis in the amount of \$530,821.74; and

WHEREAS, a Purchase Order will be issued directly to the manufacturer Vac-Con Inc., Green Cove Springs, Florida, while Municipal Maintenance Equipment, Inc. will provide training, warranty support, and future service for the equipment; and

WHEREAS, TPW and Finance Department staff request Council approval of the Purchasing Agent's issuance of a Purchase Order with City PO Terms and Conditions through the Sourcewell Cooperative Agreement 101221-VAC.
