RECOMMENDATION

It is recommended by the Police and Finance Departments that the Council, by resolution, approve a Third Amendment to General Services Agreement Number F001636 with Clean Harbors Environmental Services, Inc., Norwell, Massachusetts, to extend the Agreement for an additional one-year period and increase compensation in the amount of \$40,000, for a total cumulative amount not to exceed \$125,000.

EXECUTIVE SUMMARY

This Agreement provides ammunition disposal for the Police Department. The current Agreement expires on March 27, 2022. Clean Harbors Environmental Services, Inc. continues to provide satisfactory services.

<u>BACKGROUND</u>

The Agreement provides packaging, loading, transportation, and proper disposal of ammunition accumulated by the Police Department to an approved disposal facility. All work performed under the Agreement is in accordance with all applicable, relevant, and appropriate Federal, State and Local laws and regulations, as well as City of Santa Rosa guidance and disposal facility requirements.

On March 27, 2018, the City Purchasing Agent approved General Service Agreement (GSA) F001636 for ammunition disposal service as may be needed for the Santa Rosa Police Department to Clean Harbors Environmental Services, Inc., Norwell,

Massachusetts. The original Agreement was for a two-year term with three (3) one-year extensions.

<u>ANALYSIS</u>

Clean Harbors Environmental Services, Inc. has agreed to extend the current Agreement with a 12% increase in unit pricing for an additional one-year period. The current Consumer Price Index (CPI) CUURS49BSA0 for San Francisco/Oakland/San Jose indicates a 12.26% increase from February 2018 to December 2021. This is the first price increase since the Agreement began on March 27, 2018. Based on the current CPI data, City staff concludes that it is in the City's best interest to extend the contract with Clean Harbors Environmental Services, Inc.

With the approval of the Third Amendment extending the term for an additional one year in the amount of \$40,000, the cumulative amount of GSA number F001636 will be \$125,000.

Under the City's Contract/Purchase Order Modification Policy III-9, the Third Amendment requires approval by the City Council.

FISCAL IMPACT

Funds for this expense are included in the Fiscal Year 2021-22 adopted budget within the Police Department as a regular operating expenditure and are expected to be included in subsequent years' budget proposals when presented to the City Council. There is no impact to the General Fund.
