



CITY OF SANTA ROSA NOTICE OF PUBLIC HEARING

THE CITY OF SANTA ROSA COUNCIL WILL CONSIDER AN APPEAL OF THE PLANNING COMMISSION'S APPROVAL OF A CONDITIONAL USE PERMIT FOR JANE DISPENSARY, A 1,997-SQUARE FOOT CANNABIS RETAIL FACILITY (DISPENSARY) WITH DELIVERY OPERATING WITHIN AN EXISTING 4,776-SQUARE-FOOT MULTI-TENANT COMMERCIAL BUILDING AT 4040 HWY 12 (SONOMA HIGHWAY); ASSESSOR'S PARCEL NO. 032-500-040; FILE NO. CUP21-073.

Notice is hereby given that a public hearing will be conducted by the City Council on Tuesday, December 6, 2022, at or after 5:00 p.m., utilizing a hybrid public meeting format. The purpose of the public hearing will be to receive public comment and recommendations prior to the City Council acting on the appeal.

The project was filed by the applicant, Mario Tamo, Jane Dispensary. The appeal application was filed by the appellant, Peter M. Spoerl, on the grounds that:

1. The Planning Commission did not consider the applicants past history of hosting consumption in their dispensaries.
2. The Planning Commission did not consider the outstanding code enforcement action pending against the application for violations of a similar project contemplated by the proposed Conditional Use Permit.
3. The project's odor control letter from the licensed engineer did not account for on-site consumption as required under the code.
4. The project was not reviewed for traffic safety impacts associated with on-site cannabis consumption.
5. The neighborhood compatibility of the project was not reviewed for compatibility with on-site cannabis consumption.
6. The staff report, presentation, and the applicant's application specifically state no on-site consumption is proposed despite the applicant's history of on-site consumption in stores within Santa Rosa thus denying the neighbors and Planning Commission the proper information to consider the project proposal.
