Dear Mayor Rogers and Councilmembers:

It has been a pleasure to work with the Climate Action Subcommittee, the Planning Commission, city staff, and members of the Santa Rosa community since early 2020 to bring this issue forward for a vote. The Coalition Opposing New Gas Stations (CONGAS) is pleased to offer its enthusiastic support for the Ordinance and zoning code text amendments outlined in the staff report to prohibit new gas station land uses and expansion of fossil fuel infrastructure for existing gas station land uses in the City of Santa Rosa. We urge your "aye" vote.

CONGAS, founded in 2019, is a Sonoma County community-based not-for-profit organization with a mission to halt the permitting and construction of new gas stations. In January 2020 the City of Santa Rosa adopted a <u>Climate Emergency Declaration</u> that included a *"call for a just transition away from fossil fuels."* This action before you is in alignment with the 2020 Declaration.

There are multiple reasons to support a prohibition on new gas stations:

- This is not a symbolic act. There are two active gas station proposals in Santa Rosa and nothing on the books to stop more permit applications from being submitted;
- Although the proposed ordinance will not affect the two completed permit applications, the fact that there are two in the city shows that the prohibition is needed;
- In both pending cases there are at least ten operating gas stations within a five-mile radius;
- There are already over 40 operating gas stations within Santa Rosa's city limits, as well as others nearby, with no demonstrable need for more;
- As pointed out in the staff report and Ordinance, this action would be consistent with Santa Rosa's own climate policies as well as those of the Regional Climate Protection Authority and the State of California in response to the climate crisis;



- This is an environmental justice issue, as pointed out by city staff in the local siting of gas stations, and given that every drop of gasoline leaves behind it a wake of destruction – from the drilling to the pumping to the transportation by rail, trucks, and pipelines to processing facilities and refineries – almost always disproportionately impacting indigenous, low income, and communities of color;
- Inevitable leaks and spills pollute surface and groundwater, and soils, impacting human health and wildlife habitats. Sonoma County is riddled with <u>leaking underground storage</u> <u>tanks</u>.

CONGAS enthusiastically supports efforts to improve walking, biking, public transit and infrastructure to support electric vehicle charging at places where people live, work, and spend time such as at shopping centers, cinemas, public buildings, and so on. However, we encourage the City Council to resist the urge to include any of these kinds of good proactive measures that can more appropriately be addressed in other arenas.

We support the recommendation of the Planning Commission and the Planning and Economic Development Department that the Council adopt this ordinance approving text amendments to Title 20 of the City Code to prohibit new gas station land uses and to prohibit expansion of fossil fuel infrastructure for existing gas station land uses.

We appreciate the time and effort staff has invested in this matter and we look forward to working collaboratively to achieve our shared objectives – an equity-centered, safe, clean-emission, climate smart future for the City of Santa Rosa. We respectfully request your vote in favor of this measure.


Dear Council Members,

Dear Dianna

I urge you to look hard and carefully into the proposal to ban any new gasoline stations here in Santa Rosa, I do know that on an environmental front it sounds like a good idea but it fails to consider several significant harmful impacts.

- Electric Vehicles are not a viable option for many in our community, travel patterns, distances and destinations do not make operating an electric vehicle a viable option. As battery technology improves and charge opportunities increase there will be a natural migration towards electric vehicles and market forces will close a number of stations, but for now you have the cart before the horse. Consider what happened to the old liberty stable.
- 2. Massive housing initiatives currently under construction in the next few years the housing stock and thus population here in Santa Rosa will be facing a massive expansion, people will bring their cars, affordable housing most likely gasoline powered vehicles, such an expansion of population calls for an expansion of infrastructure and services, not a stall of contraction of these. More residents necessitate more energy, water, roads, retail and gas stations at least initially.
- 3. Equity, inclusion, diversity a ban on gas stations will impact low wage earners and certain areas of our city disproportionate as the limit of available fuel sources in a growing city and reduction in price competition will hit the pocket books of this segment much harder. The considered gas station ban action is in conflict with the work Santa Rosa is doing to make housing more affordable.

Again I will mention that as battery technology evolves and as charging stations populate the landscape the natural market forces will bring about the transition of reducing gasoline stations, let's

just not get the cart before the horse to the frustration and injury of many in our community.
