Sanitary Sewer Collection System

Applicable Rules & Regulations:

- Statewide General Permit for Sanitary Sewer Systems
 Santa Rosa Sanitary Sewer Management Program:
 - Eliminate SSOs
 - Maintain & improve condition of collection system
 - Minimize infiltration/inflow into the system & provide adequate capacity

Non-Compliant Events	Description	Impact
8 Sanitary Sewer Overflows	Each SSO met Category 3: <999 gallons, Did not enter a waterway, or All flow retrieved. (Category 3 = Lowest impact.)	Total Combined Volume = 2,318 gallons

1 Period of No Disinfection	1 hour duration	Unstable Power during Fire
Discharge Outside Discharge Season (Prohibited between: May 15-Sept 30)	Leakage from Delta Pond into Santa Rosa Creek observed on June 30, 2017	Leaks from Butterfly Valve, Slip- lined Transition from prior to current discharge system & magnetic flow meter

Permit to Operate (PTO)	Annual Source Testing required for renewal	Operation with expired PTO. (No 2016 annual source testing - conducted in 2017)	\$1,500 proposed
