Dear Honorable Members of the City Council,

On behalf of Greenbelt Alliance, I urge you to make a robust investment in a down payment assistance program, using either the American Rescue Plan Act funds, or the remaining funds available from the PG&E Settlement.

Investing in a down payment assistance program could make a dramatically positive impact on homeownership and community preservation. As we know, owning a home doesn't just help our young people, workforce, and equity priority populations put down lasting roots in this community – owning a home is a powerful economic tool that enables someone to build personal wealth in a tangible asset that appreciates over time. It is also an economic tool that will provide the family with support through all stages of life.

When a child is born, it provides its parents with a static payment that does not increase overtime as rent does. When that child leaves home for college, his or her parents can take out a home equity line of credit to finance their child's education. The same is also true for families who need to financially weather unforeseen hardship, such as a medical emergency. When the parents themselves age, they can age in place and pay for their care, because their mortgage will be paid off. That, or they can do a reverse mortgage and remain in their home. Finally, homeownership helps guarantee generational wealth when the asset transfers from parents to children.

A down payment assistance program is also an important and meaningful investment in a more equitable city. By instituting a down payment assistance program in Santa Rosa, you will help communities of color own property and develop robust wealth from the property's appreciation. As far as public policy is concerned, down payment assistance is a simple, yet elegant, way to begin to correct the disadvantages that have accrued over centuries of slavery and, more recently, practices such as redlining, which was the process of denying people of color credit to own homes in nice neighborhoods.

The Santa Rosa City Council spends millions per year to build housing, which is a criticallyimportant investment. But to fully build out a robust housing program, down payment assistance should certainly be a component of the City's housing policy. It is unequivocally the most time efficient, cost efficient, and equitable way to house Santa Rosa's equity priority populations and workforce.

I'm Pat Kuta, making an Appeal for funding a Roseland Community Center

Roseland is at a crossroads. It has a dedicated community advocate representing it on the City Council. The County and City are investing in a Roseland Library, and basic civic infrastructure is being upgraded. Roseland has a vibrant commercial center, drawing patrons from through the area and schools it takes pride in. Roseland has the largest concentration of people of color in Santa Rosa. It is an area with rich cultural diversity.

It is also being developed as one of the few areas with buildable properties in the City while it still addresses the significant environmental hazards of the industrial pollution left behind from the past uses.

A 2014 Portrait of Sonoma County highlighted several, significant challenges facing the 1st district. The three electoral precincts in Roseland have the lowest rankings in "human development" in terms of life expectancy, educational achievement, and median income. It also has the smallest amount of acreage set aside for public parks and gatherings in the City.

At this moment in time, Roseland and, indeed the city of Santa Rosa are challenged with a unique opportunity with one-time federal funding to create a true community hub that will serve as the focal-point of needed forms of community and economic development. And the ARPA and City guidelines support investment in Roseland.

Santa Rosa made a significant investment in a permanent Roseland Library which could be an anchor of this proposed hub. Community awareness and excitement about the scope and character of this evolving community center is high with the focus being on a true, multi-service multi-cultural *community* center.

With funding, the Roseland Community Coalition stands ready to enter into a community engagement process to learn what features, components and amenities the residents of Roseland would like to see at this site.

Dear Mayor Rogers, Vice Mayor Rogers, and Honorable Councilmembers:

Generation Housing strongly encourages you to make a meaningful investment in a down payment assistance program, with either American Rescue Plan Act or PG&E settlement funds. This investment would be one of the strongest ways to leverage the City's one-time funds by helping young people, critical workforce members, and marginalized communities clear the hurdle of onerous down payments to become homeowners.

Owning a home is a powerful economic tool that empowers individuals and families to build personal and intergenerational wealth through an appreciable tangible asset. Home equity is an asset that can support retirement, pay for college, buffer unforeseen financial emergencies, and break family cycles of poverty. Increased homeownership helps communities by allowing folks to put down lasting roots, improving the strength of our workforce and local economy, increasing equitable opportunity, and attracting and supporting a more diverse population.

Finally, this investment is a start at undoing the harm done by racist housing policy and lending policy, a shameful legacy of slavery that exists to this day — maintaining the geographic segregation in cities that it created and the wealth gab between white people and our communities of color. These historic patterns of segregation must and can be undone and this investment can help achieve that.

Generation Housing's work has been focused more on supply-side solutions to our housing crisis. But down payment assistance falls squarely within our commitment to building our diversity of homes, and to ensuring that everyone not only has a place to call home, but also has the means to contribute to an equitable, healthy, and resilient community. We urge the City Council to make this impactful and equitable investment in the future of our community.
