




Lake Mendocino Storage




Lake Sonoma Storage

Santa Rosa Cumulative Drought Reductions



- In December, Santa Rosa residents reduced water use by 13% in compared to 2020
- From July through December, water use has been reduced by 23% compared to 2020





2022 Irrigation Season

- Establish Initial Allocations in January 2022
- Allocate Interruptible Recycled Water Equally
 - Allow Recycled Water use for Frost Protection
 - Accommodate Trading of Allocations
 - No Irrigation Schedules
- Guarantee Allocations until September 30th

Anticipated Minimum Deliveries

Geysers	4.2	4.0	4.2
Ag Irrigation	1.7	0.6	0.9+
Urban Irrigation	0.4	0.4	0.5

The Details

- 900 MG Initial Allocations in January (~65%)
 - Divided Amongst 70 Permitted Parcels
 - Based on 3-years of Historical Use (2017-19)
- Increase Allocations Monthly until June, as Supply Permits
- Frost Protection Use will Count toward a User's Allocation
- Allocations are Tracked at First Use and Guaranteed until September 30th, 2022

The Caveats

- Increase in Allocations will Depend on Weather and if a Discharge needs to occur
- All Recycled Water will be Charged per Fee Schedule
- Need to Maintain 200 MG Min in Total Storage
- Delta Pond/Geysers Connection Project Construction will Impact the System, we will work to minimize Impacts to Deliveries

The Schedule

- January 18th Held 1st All-Users Meeting
- By End of January Send out Allocations via Email and Letter Notices
- Send Increased Allocation Notifications Monthly until June (Supply Permitting)
- Early April Hold 2nd All-Users Meeting
