Please Reject Stony Flats raping of nature & Roseland Creek!

Please do not approve this housing development proposal at this site. The area should be saved for a park next to Roseland Creek to help with park equity for the disadvantaged, underserved and over-burdened areas of the Roseland Creek neighborhoods. This project is in the wrong place and there should be an effort to work with the developer for a transfer of development rights to an area along Sebastopol Rd. There three to four times as many housing units could be built in a much smaller space.

This could be done with high rise buildings as tall as 10 or more stories high in the commercial corridor area. There is an excellent site next to Exchange Bank on Dutton Ave. Mr. Alvarez and Mr. Bruegeman both know of this site plus there are others nearby closer to transit for a true Transit Oriented Development. This proposal before you today lacks an accurate and complete environmental review of the negative and unavoidable significant cumulative impacts the project will have on the community, the environment, and nearby neighbors.

The existing environmental documents are inadequate, therefore an Environmental Impact Report is requested to address the damage to habitat for California Tiger Salamander as well as the negative impacts to Roseland Creek. This waterway must be protected from environmental damage and effects of pollution. The creek drains to the Laguna de Santa Rosa which empties into the Russian River where efforts are afoot save local fish habitats. Also increased automobile use in the area will have negative environmental effects, both in terms of pollution and quality of life. This is because Stony Pt. Rd. is a heavily traveled road with many high speed users. Fatal crashes have occurred nearby.

While project proponents claim "low impact development" will occur no such thing is true. The moving of dirt on the site will be a high intensity disruption of the habitat and will potentially increase flooding in the area due to increased runoff from the impermeable surfaces to be built on now open natural land. The list of defects and faults with this project is too long for this email to be complete but this request is made for this to be read into the record today plus a request for a full Environmental Impact Report to be done to adequately address all cumulative negative impacts.

Hello City of Santa Rosa City Council,

I can't seem to participate in todays meeting but I have been watching it live. I wanted to comment on the Stony Point Flats project. I have been photographing and videotaping the intersection of Stony Point and Giffen Ave. During peak traffic flows (especially during school drop off and pick up) the queue line for the left turn lane onto Giffen Ave (west bound) is completely filled and backs up. The problem with this housing development depends on this left turn for the new tenants to make U-Turns. I feel this is dangerous and requiring new cars to make U-Turns at this intersection.

An alternative is to construct the extension of North Point Parkway as part of the housing project.

Two other requests:

- a. Please confirm the hydraulics have been updated to the current pad elevation as I saw the intended outlet pipe completely covered by several feet of water during the last rain event.
- b. Please install a solid wall along the north side of the proposed project parking lot to mitigate against cars starting noises and headlights pointing directly at the existing houses.
