RESOLUTION OF THE COUNCIL OF THE CITY OF SANTA ROSA APPROVING A COOPERATIVE AGREEMENT BETWEEN THE STATE OF CALIFORNIA, ACTING THROUGH ITS DEPARTMENT OF TRANSPORTATION (CALTRANS), AND THE CITY OF SANTA ROSA FOR QUALITY MANAGEMENT ASSESSMENT FOR RIGHT OF WAY SUPPORT, RIGHT OF ACQUISITION, AND UTILITY RELOCATION ACTIVITIES FOR THE HIGHWAY 101 BICYCLE AND PEDESTRIAN OVERCROSSING PROJECT

WHEREAS, the City would like to construct a pedestrian and bicycle overcrossing at US Highway 101 to include a 5-foot-wide sidewalk and an 8-foot-wide bike path, which will provide a much-needed improvement to the existing pedestrian & bicycle connectivity, and reduce pedestrian/ vehicle conflict, and improve more opportunities for alternative transportation; and

WHEREAS, CALTRANS has requested that the City adopt a resolution approving and authorizing the execution of Cooperative Agreement in conformance with CALTRANS' project development process to advance the Project; and

WHEREAS, a cooperative agreement between the City and CALTRANS is necessary in order to establish agency responsibilities for work and funding; and

WHEREAS, CALTRANS requests that the City, by resolution, approve the Cooperative Agreement which outlines the terms and conditions of cooperation to complete the Right of Way phase of the project; and

WHEREAS, a cooperative agreement between CALTRANS and the City establishing roles and responsibilities for the right of way phase is necessary to proceed with right of way acquisition and utility relocation activities for the Hwy 101 Bike and Pedestrian Overcrossing project.

NOW, THEREFORE, BE IT RESOLVED that the Council of the City of Santa Rosa approves the Cooperative Agreement, in substantially the form attached to this resolution as Exhibit A and made a part of herein, subject to approval as to form by the City Attorney.
