BACKGROUND

- January 11, 2022 Hearn Community Hub site acquired
- February 15, 2022 Resolution RES-2022-029 passed by Council appropriating the American Rescue Act Plan (ARPA) and remaining PG&E settlement funds and approving spending plans
 - Roseland Community Center (\$10,000,000)
- March 21, 2022 Request for Proposals released for the Hearn Community Hub Needs Assessment and Collaboration Project

<u>HEARN COMMUNITY HUB – NEEDS ASSESSMENT</u> <u>AND COLLABORATION PROJECT</u>

- 1. Develop a Community Needs Assessment in collaboration with the OCE and key project stakeholders.
- Implement the Community Needs Assessment, conducting data collection utilizing a variety of outreach methods. Consultant will analyze collected data and develop a Needs Assessment Summary.
- 3. Conduct in-depth community engagement process to provide community members with opportunities to weigh-in on the vision for the Hearn Community Hub.
- 4. Create a final report, incorporating findings from the Needs Assessment and the Community Engagement Strategy, which will be presented to Council.

The expected completion date for this project is September 30, 2022.
