## Re: Amendment \#2 for Construction Management and Inspection Services for North Trunk Sewer Replacement - Mendocino Avenue to Terra Linda Drive (Project)

## Dear Greg:

Per previous discussions and in summary of the additional work that was added to construction contract with Team Ghilotti, Inc. we are submitting this request for a second amendment to our original contract for CM and Inspection services.

The project scope for the Contractor was increased by the recent addition of over 1500 lineal feet of new 8 " DIP water main with approximately 15 tie-ins to existing facilities and all associated appurtenances that has an approximate value of over $\$ 1,000,000$. This work was partially completed under amendment \#1, but the Contractor's estimated time for this work ( 51 working days ) to the contract for the installation was underestimated due to various conflicts in the field, etc. Also at this time, the work required to complete the Project punch list has expanded beyond our estimated timeline. Consequently, we are requesting an additional amendment to our contract to finalize the Project. Briefly summarized below are the key items that have made this request for an amendment to our contract necessary.

- Acknowledgement by Team Ghilotti that the originally advertised schedule of 200 working days was not sufficient and the first estimate of needing a minimum of 175 additional working days with a projected July 5,2022 , end date was incomplete. We are conservatively estimating a completion of minimum of 8 weeks from the July 5 end date.
- Continued need for random weekend work as Contractor works on final punch list items
- Additional time for the Construction Manager to close this project out due to the much longer timeline of working days than originally anticipated.

This project continues to remain an amazing opportunity for our team, and we hope that you have continued confidence in our firm and staff as we close in on the final closure!

In summary, our request for an amendment is to continue our CM and Inspection efforts for the listed items as well as the mandatory processing requests for information, field directives, change orders, pay estimates and weekly meetings.
