### Small Business Support - \$1,000,000

#### PROGRAM ELEMENTS

- 1. Qualified Census Tract Focused Business Tenant and Façade Improvement Program
- 2. Mercadito relocation
- 3. Parklet Build Out



### Tenant & Façade Improvement Program

- 1 grant application for either or both programs.
- Eligibility determined by location in QCT area.
- Proposed TI max \$10k, plus façade art option
- Façade Program managed under contract with a nonprofit art organization. Includes facilitation, design, and installation services.
- Targeted English and Spanish marketing and outreach to identify potential applicants.
- Proposed budget: \$500-800k (scale based on other needs)





#### **Mercadito Relocation**

- Funds to relocate merchants, ideally with room to incubate additional businesses
  - Set aside to address tenant improvements and potential lease needs
  - Seeking fiscal sponsor/community partner
- Proposed budget: \$100-250k





#### **Parklet Build-Out**

- Grants to offset costs of year 1 Parklet Program Fees.
- Proposed 50-75% of total fees, determined by design elements including public art.
- The Public Art Program will contract with artists to artwork design, and installation services for participating projects.
- Proposed budget: \$100-250k



# CHILDCARE SUPPORT PROGRAM Facility Fund-\$2,900,000

**The Fund** provides financial support through grants for buildout of new childcare/early learning facilities included in new housing or business construction, as well as rehabilitation, renovation and repair of existing childcare and early learning facilities. Funds can be used for:

- Construction costs
- Mechanical, electrical & plumbing
- Fees for permits and inspection
- Cost of architectural design
- Engineering & site development costs

- Fixtures, finishes & Equipment
  - Required for childcare facility licensing
  - To enhance the environment to increase program quality and outcomes
  - To increase accessibility to children with special needs
  - Outdoor play equipment and functional landscaping



# CHILDCARE SUPPORT PROGRAM Child Savings Account - \$1,575,000

**This CSA** will be administered through the existing First 5 Futures program a First 5 Sonoma County program that provides a free College Savings Account to eligible children aged 2 to their 5<sup>th</sup> birthday.



- First 5 Sonoma County makes an initial deposit of \$200 for every eligible child.
- Families participating in this program have the opportunity to receive up to an additional \$300 in incentives

- Funds will be invested on behalf of the child.
- Funds are available for withdrawal after the child graduates from a high school and enrolls in a college or career education program.
- Accounts set up with ScolarShare529
