Ms. Murray,

I am not able to attend the 10/18/2021 meeting regarding the permitting of Flora Terra as I'll be in Wyoming. But I did want to reach out and let my opinion be known on this project as I own and live in our condominium at Mission Lakes, directly behind Velaro and across from the proposed project.

I am 100% against the project and quite frankly I'm shocked it is even being considered by the City of Santa Rosa.

From Highway 12 north the area is multi family and single home family dwellings. The Valero station and the small stripe mall area on the north/east corner are the only commercial property north of Highway 12 to Montecito. Within an approximately 2 mile area, there are 3 schools, elementary to high school, that this cannabis dispensary would be near. The traffic situation, especially since the city removed the no U-Turn regulation at the island across from our condominium complex creates a traffic nightmare when attempting to get in or out of our drive going north or south. The traffic this dispensary, if approved, will bring will make this area even MORE dangerous for traffic. There is already a liquor store in the complex that generates traffic, and is a drawing point for the growing vagrant/homeless population that homeowners have to deal with, because the city is incapable of controlling this population. This dispensary if approved will increase that troublesome group even more.

In summary, this dispensary is not needed and not wanted in our neighborhood. The type of people that it will draw and attract are not what our children and seniors, need to be tempted and exposed with. The increased traffic it will cause is dangerous especially the way the city has this intersection regulated. I don't feel the city council has any idea of the family makeup off our community, if they did they would know this is a bad proposal for a family neighborhood. Keep these types of business in business area, not family home areas.

You already allowed 1 dispensary on Highway 12 in Rincon Valley, it failed, Rincon Valley residents won't support or want another dispensary in our neighborhoods.

Thank you for writing a very clear email stating your objections to the proposed Flora Terra dispensary at 4575 Highway 12.

On December 19, 2017, the City Council enacted comprehensive regulations for commercial cannabis after the State of California approved the sale of cannabis for adult use. The cannabis ordinance does not regulate setbacks to residential land uses. The only setbacks regulated by the cannabis ordinance are the distance from schools and the distance from other cannabis dispensaries. The proposed dispensary is more than 600 feet from the schools in this area and 600 feet from the approved and proposed dispensaries. Therefore, the proposed dispensary is consistent with the required regulations.

I wanted to comment via email to the proposed Flora Terra Cannabis dispensary planned for my neighborhood, as I will be on shift at work the day of the Zoom meeting.

I am very opposed to the city authorizing the Permit for this business in my Rincon Valley neighborhood. There are 3 dispensaries already open and doing business in a 2-3 mile radius of this proposed dispensary. 1 at 4880 Sonoma Highway, less than a mile from this proposed site, another at 4036 Montgomery again less than a mile from this proposed site, and a 3rd at 755 Farmers lane.

Is the City Planning Commission viewing our neighborhood as the next Santa Rosa Avenue for placement of businesses that should not be selling their products in family oriented neighborhoods? There are 14 public and private schools in close proximity of 1-3 miles to this proposed business site. There is no need to expose them to this type of business, the clientele and associated negative influence these types of business bring in.

I have owned a home in this neighborhood since 1993, and it is being destroyed by poor judgement and decisions of our city government, and this is another one of these destructive decisions. Our neighborhood is already overloaded with a long term vagrant/homeless community that grows daily due to lack of enforcement. Crime and filth are growing daily, caused by this out of control group of individuals. There is already a liquor store in the same strip mall that you are now proposing to add a marijuana dispensary into. Hi Mark,

Your concerns related to existing traffic conditions and congestion associated with traffic northbound on Mission Avenue merging from two lanes to one, pedestrians crossing at unprotected locations, and the location of a northbound bus stop between the two driveways to the project site are all valid concerns related to traffic operation and safety.

However, the limited amount of additional traffic the proposed dispensary would generate can reasonably be expected to have an unnoticeable effect on these existing conditions. While the traffic study addressed the net change in trips associated with the prior use, even had there been no building and the project resulted in all new trips, an operational analysis would not have been required as the City's threshold for such is 50 peak hour trips. The proposed dispensary has a peak hour trip generation of 45 trips. The City has found projects generating fewer than 50 peak hour trips to have a limited effect on traffic operation.

The incidence of pedestrians crossing at uncontrolled locations and the operation of the bus stop and the merge are all issues that are important to the City. Still, they would not be addressed as part of the review of a development project. Instead, these items can be referred to the Traffic Engineering Division for review and resolution, including asking the Transit Department to relocate the bus stop.

As for the food truck, I don't see any permit allowing them to operate there legally.

Hi Monet,
Thank you very much for your quick and informative reply.

Oh, I thought the food truck was there legally and had a connection to the El Torito supermarket, because it is usually parked in front of El Torito supermarket in the parking lot at the South driveway entrance.

In addition to the bottleneck congestion concerns mentioned in my prior email, the traffic report mentions the bus stop on Mission blvd that lies between the middle and north driveways. It is located Exactly where Mission merges from two to one lane and the left turn lane ends.

The traffic report indicates that the traffic impact of the dispensary should be less than the traffic impact of the Starbucks coffee shop. The Starbucks coffee shop has not been there for quite some time. I am expressing the concern that increasing the Current traffic congestion would likely increase Current vehicle collisions in the area. The report does not identify how the number of trips in and out of the three driveways affects the vehicle collision rate in the area.

Thank you for providing your comments and concerns about the proposed Flora Terra dispensary at 4575 Highway 12.

A Traffic Report is prepared by W-Trans (attached) and reviewed by the City's Traffic Division, and no additional requirements were placed on the Project. The report concluded that the Project would result in a less-than-significant transportation impact. The proposed dispensary would have less parking demand than the prior coffee shop and would be expected to result in fewer daily trips on the surrounding roadway network.

I look at the City's permitting system and do not see any permit for the food truck on this site. I will contact our Code Enforcement Department and inform them about the illegal mobile food truck parked on the site.

I received a Notice of Public Hearing in the mail that provided your contact information.

The retail complex cannot adequately accommodate another high traffic business with quick customer interactions such as a dispensary.

- The location of the retail complex provides high advertisement visibility on a major thoroughfare however entry and egress to the parking lot is very congested, which may have led Starbucks to move across the street.
- The liquor store and a food truck in the retail complex parking lot are businesses that have high traffic and quick customer interactions. They generate a lot of vehicle traffic entering and exiting the parking lot and they generate a lot of foot traffic from people walking directly across Mission blvd. from the condo complex or gas station. Few people walk all the way to the corner cross walk at Mission blvd. and hwy 12.
- Directly in front of the retail complex parking lot driveways, within approximately 150 feet from Hwy 12, Mission blvd. funnels from two lanes into one lane. Right lane traffic backs up due to the lanes merging and vehicles slowing to enter and exit the parking lot. Cars caught in the right lane, in the Mission blvd./hwy 12 intersection, swerve into the left lane, to clear the intersection, causing the left lane to back up as well. Also, directly in front of the retail complex parking lot driveways, where the two lanes merge into one lane, there is a left turn lane into a condo complex that further backs up the left lane.

It is not prudent to further confound this traffic/pedestrian hazard by permitting this dispensary, or any other high traffic quick customer interaction business, to occupy this retail complex.
