FIRST AMENDMENT TO AGREEMENT FOR ACCEPTANCE OF BIOSOLIDS AND LAND APPLICATION NUMBER F001428 WITH GILARDI & JACOBSEN AG SERVICES, INC.

This First Amendment to Agreement number F001428, dated June 16, 2017 ("Agreement"), previously amended by Amendment to Consent, dated July 25, 2017, is made as of this _____ day of _____, 2018, by and between the City of Santa Rosa, a municipal corporation ("CITY"), and Gilardi & Jacobsen Ag Services, Inc., a California Corporation, as the user ("USER").

RECITALS

- A. CITY, USER and OWNER entered into the Agreement for terms pursuant to which USER receives and applies Biosolids to cropland on Farm.
- B. CITY and OWNER entered into Amendment to Consent for terms pursuant to which OWNER will be named as additional insured on City's general liability insurance policy.
- C. CITY and USER now desire to amend the Agreement for the purpose of extending the Term for four years and increasing Compensation.

AMENDMENT

NOW, THEREFORE, the parties agree to amend the Agreement as follows:

1. TERM

Pursuant to Section 2 of the Agreement, the parties hereby agree to extend the term of the Agreement for four additional years, to April 30, 2022.

2. COMPENSATION

2.1 Section 12.1 of the Agreement is amended to increase the compensation payable to USER under the Agreement as follows:

"As compensation to USER hereunder, CITY shall pay USER as follows:
\$3.25 per wet ton for application of Biosolids;
\$7.10 per ton for application of Lime; and
\$40.00 per acre for application of herbicides.

2.2 Secton 12.2 of the Agreement is amended to increase the compensation Page 1 of 3

Amendment to General Services Agreement Form approved by the City Attorney 8-8-14 payable to USER under the Agreement as follows:

"Total maximum compensation to be paid hereunder shall in no event exceed the sum of \$63,000.00 for spreading of Biosolids and Lime and \$46,500.00 for spraying of herbicide. The Chief Financial Officer is authorized to pay all proper claims from Charge Number 130807-5321."

All other terms of the Agreement shall remain in full force and effect.
