

RESOLUTION NO. 9325

RESOLUTION OF THE COUNCIL OF THE CITY OF SANTA ROSA ORDERING VACATION OF AN ALLEY BETWEEN "A" STREET AND WASHINGTON STREET IN THE CITY OF SANTA ROSA

WHEREAS, the Council of the City of Santa Rosa did on the 31st day of March, 1970 adopt Resolution No. 9290 declaring its intention to consider the vacation of an alley between "A" Street and Washington Street, south of Seventh Street in the City of Santa Rosa, County of Sonoma State of California; and

WHEREAS, said Resolution No. 9290 fixed the 28th day of April, 1970 during the 8:00 p.m. session of the City Council, in the Council Chambers, City Hall, Santa Rosa, California, as the time and place for hearing all persons interested in or objecting to the proposed vacation of the property described herein; and

WHEREAS, said Resolution No. 9290 was duly published as required by law and at least three notices of such vacation were duly posted along that part of the right of way proposed to be vacated, which notices recited that the said resolution had been adopted and stated the time and place of hearing; and

WHEREAS, the Council of the City of Santa Rosa has duly held the hearing at the time and place above stated and there being no objections submitted, or said objections having been overruled;

NOW, THEREFORE, IT IS RESOLVED, by the Council of the City of Santa Rosa that property described herein is not necessary for present or prospective street purposes and said property is hereby abandoned and vacated SAVING AND EXCEPTING that there is hereby reserved to all public utilities the right to maintain, repair, construct or reconstruct sewers, water pipes, gas pipes, power lines and other public utility facilities now in place in said alley and the right of all necessary entry therefor.

IT IS FURTHER RESOLVED, that the City Clerk is hereby directed to cause a certified copy of such order of abandonment to be recorded in the

office of the County Recorder of Sonoma County.
