SECOND AMENDMENT TO GENERAL SERVICES AGREEMENT NUMBER F001626 WITH JAMES FURULI INVESTMENT COMPANY, INC. DBA ENVIRONMENTAL DYNAMICS

This Second Amendment to Agreement number F001626, dated February 15, 2018 ("Agreement") is made as of this _____ day of _____, 2021, by and between the City of Santa Rosa, a municipal corporation ("City"), and James Furuli Investment Company, Inc. dba Environmental Dynamics, a California Corporation ("Contractor").

RECITALS

- A. City and Contractor entered into the Agreement for Contractor to provide for Contractor to provide janitorial services for various City of Santa Rosa Water Department locations, as previously amended.
- B. City and Contractor now desire to amend the Agreement for the purpose of extending the term for a two-year period with a 5% increase in unit price, and increasing compensation.

AMENDMENT

NOW, THEREFORE, the parties agree to amend the Agreement as follows:

1. SCOPE OF SERVICES

Exhibit C to the Agreement is replaced by Exhibit C-1 to this Amendment.

2. TERM, SUSPENSION, TERMINATION

Pursuant to Section 6(a) of the Agreement, the parties hereby agree to extend the term of the Agreement for an additional two years.

3. COMPENSATION

Section 4 of the Agreement is amended to increase the compensation payable to Contractor under the Agreement by \$348,877.44 plus \$80,000 contingency to read as follows:

"The total of all fees paid to Contractor for the satisfactory performance and completion of all services set forth in the Agreement shall not exceed the total sum of \$847,165.56 plus a total contingency of \$160,000 for Miscellaneous Services for an aggregate not-to-exceed amount under the

All other terms of the Agreement shall remain in full force and effect.

This clause does not affect the "productscompleted operations" coverage provided to the named insured(s).


