RECOMMENDATION

It is recommended by the Transportation and Public Works Department that the Council, by resolution, approve and adopt the Public Involvement Plan for the Transit Division's Short Range Transit Plan 2022 update.

EXECUTIVE SUMMARY

The involvement of a diverse cross section of the Santa Rosa community is integral in developing a robust Short Range Transit Plan (SRTP). This SRTP will provide the foundation for service changes and delivery over the next three years. Having feedback from the public is essential to create a plan that delivers service in a way that is most beneficial to the public. Staff have created a Public Involvement Plan to ensure the outreach campaign for the SRTP is thorough and successful.

BACKGROUND

MTC, in cooperation with the Federal Transit Administration (FTA), requires public transit operators that are FTA grantees to prepare and regularly update an SRTP to help inform regional transportation planning and programming activities. On June 7, 2022, Santa Rosa CityBus staff conducted a study session with the Council. The study session gave the Council an overview of the SRTP process staff plans to undertake between June 2022 and December 2022 when the plan is due. The attached Public Involvement Plan provides a detailed roadmap for staff's outreach during that period.

PRIOR CITY COUNCIL REVIEW

At the June 7, 2022 meeting, CityBus staff conducted a study session to review the purpose and content of a Short Range Transit Plan.

ANALYSIS

CityBus staff have had a wide range of experience with public outreach over the past five years. The Reimagining CityBus process in 2015-17 provided staff with many opportunities to determine which practices are most effective in reaching riders. For the SRTP outreach CityBus will be leveraging that knowledge as well as working with staff in other departments to learn their best practices. For the outreach staff has created five goals:

- 1. Conduct an interactive and collaborative process to engage a diverse range of riders, stakeholders, and residents.
- 2. Actively seek out and promote the involvement of groups that have been traditionally under-represented in planning processes.
- 3. Leverage existing community partnerships and develop new ones to enhance community engagement.
- 4. Ensure all parts of the public engagement process are transparent.
- 5. Maintain a two-way flow of information at all times between City staff and the public.

Staff hopes to achieve these goals by completing the task show in the timeline below.

In-person discussion out in the field will be the most important part of the public engagement. Staff has found time and time again that speaking with riders at stops or on the buses yields the most impactful information. While most information that staff collects in these instances is subjective it often supports or highlights more objective information from data collection. Throughout the process CityBus will also leverage technology to provide additional avenues for riders to engage with staff. Using Zoom has worked well for other departments when engaging the public and CityBus hopes that is also the case for during its outreach efforts.
