PROJECT NAME - Fall 2021 General Plan Amendment Package - 38 Degrees North Phase 3 Apartment Homes

PROJECT ADDRESS - 2660 Petaluma Hill Road, Santa Rosa, CA 95404

PROJECT DESCRIPTION - The City Council will consider General Plan Diagram and Text Amendments and Rezoning of the 38 Degrees North Phase 3 Project, which includes the entire 15.82-acre 38 Degrees North site. The requested General Plan Diagram Amendment would change the Medium Density Residential (8.0–18.0 units per acre) and Retail and Business Services land use designations to Medium High Density Residential (18.0-30 unit per acre) and eliminate the "star" symbol designating the site as a location for a Community Shopping Center, as well as remove reference to Community Shopping Center on pages 2-12, 2-22, and 2-30 of the General Plan. The Project's Rezoning application proposes a Zoning amendment to change the existing zoning designations from CSC (Community Shopping Center) and PD-96-001C to R-3-30 (Multi-Family Residential). The Project includes an Addendum to the previously adopted Phase 2 Mitigated Negative Declaration (MND) pursuant to California Environmental Quality Act (CEQA) Guidelines Section 15164 where no circumstances under CEQA Section 15162 are triggered. The application has been filed by Dave Eadie, KW Petaluma Hill Road LLC. File No. PRJ21-011
