REVIEW OF COUNCIL FEE WAIVERS

Timeline of Council Action

- April 14, 2020: Council authorizes free hourly parking at all parking meters and garages to be effective 4/15/20. Council also authorizes all permit fees for garages and lots retroactive to 4/1/20.
- June 16, 2020: Council authorizes resumption of paid parking and fee reductions
- July 1, 2020: fee reductions begin
- December 15, 2020: Council extends fee reductions
- June 22, 2021: Council extends fee reductions
- December 14, 2021: Council extends fee reductions
- Current end date set for June 30, 2022

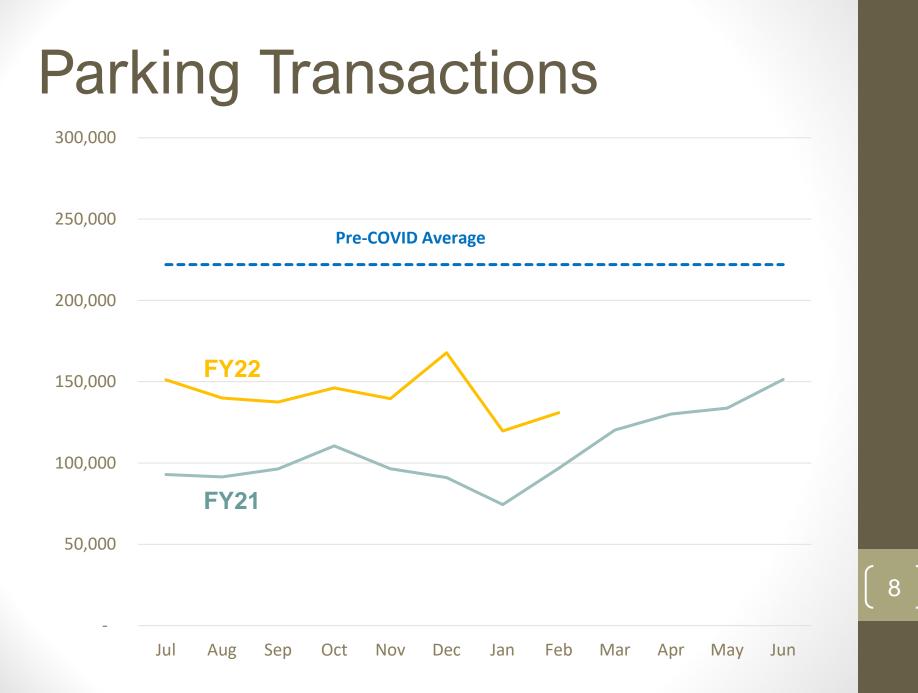

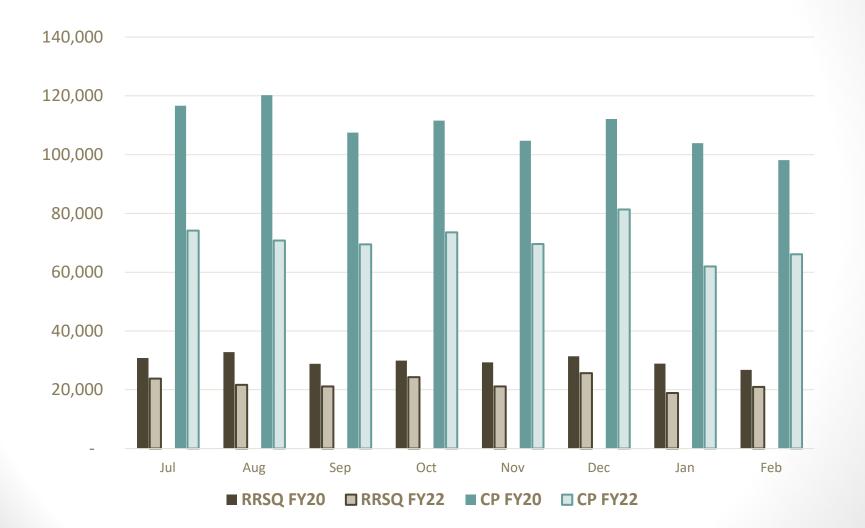
