



# Update on Guaranteed Basic Income Pilot June 14, 2022

### Leveraging Funding for Greater Impact

- Total Cost of Project: \$5.1 million
  - 305 families x 24-months x \$500 + incentives = \$4 million
  - Outreach staffing, payments platform, research evaluation = \$1.5 million
  - Project management & staffing (2.5 years) = \$600k
- Leveraged Funding Sources
  - County of Sonoma: \$3.05 million (ARPA)
  - City of Santa Rosa: \$1 million (ARPA)
  - City of Petaluma: \$640k (ARPA)
  - City of Healdsburg: \$250k (ARPA)
  - First 5 Sonoma: \$200k (Prop. 10)





# GBI Pilot Project: Coalition Member Roles FIRST

#### First 5 Sonoma County

- Project management, administration, coordination, communications
- Fiscal agent & compliance w/ ARPA reporting
- Dedicate Prop. 10 funding to support project needs

#### CBO partners

- Culturally/linguistically responsive outreach to families in QCTs
- Application assistance
- Benefits counseling
- Cities of Santa Rosa, Healdsburg & Petaluma
  - Dedicate ARPA funds to support GBI participants within jurisdictions
- County of Sonoma
  - Dedicate ARPA funds to support GBI countywide, pilot evaluation, payment platform, outreach staffing
  - Secure income eligibility exemptions for CalWorks, CalFresh, MediCal
  - Outreach directly to eligible Human Service Department clients

### **GBI Pilot Project: Subcontractor Roles**

#### Social Policy Research Associates

- Develop robust, mixed-methods evaluation design to understand impact of GBI on target population
- Point-in-time surveys of all GBI recipients
- In depth interviews of sample of GBI recipients
- Detailed report that will contribute to national research agenda on guaranteed income

### Fund for Guaranteed Income

- Design and host accessible, user-friendly online application
- Disperse monthly \$500 payments to selected participants via debit card, direct deposit and other methods

### City of Santa Rosa's Children Birth-5

FIRST 5 sonoma county

- 1,600 births annually
- o 50% births Medi-Cal eligible
- o 11,500 children under age six
- Less than 50% entering kinder are ready to succeed
- 50% households w/children, 0-5, struggle to meet basic needs
- 70% single parent households struggle to meet basic needs



# Santa Rosa Child Care & Early Learning Facility Fund

PURPOSE: To expand access to child care options for working families, establish sustainable funding for high-quality childcare facility development and rehab.

Funds can be used for:

- Construction costs
- Fixtures, finishes and equipment (FFE)
- Fees for permits and inspection
- Cost of architectural design
- Engineering and site development costs
- Mechanical, electrical and plumbing (MEP) for new or existing facilities

**Eligible applicants:** LEAs, 501c3s, private ECE & child care operators, Licensed Family Child Care owners, license-exempt providers





## Santa Rosa Child Care & Early Learning Facility Fund

Logistics & Timeline for Grants Program:

- RFP Process late summer 2022 (Round 1)
- Projects selected by November, 2022
- Second round in 2023
- All funds obligated by 12/31/24
- All funds expended by grantees by 12/31/26
- Award may cover up to 75% of total cost
- Facility must be located within the City of Santa Rosa
- Priority points for facilities that provide care for infants and toddlers
- Priority points for facilities that are located within the QCTs
- Grantees will submit Annual Use of Funds report through 2030 (# and demographics of children served)





# Santa Rosa Child Care & Early Learning Facility Fund



Logistics & Timeline for Revolving Loan Program:

- Segregated revolving fund account will be interest earning
- Application open late summer 2022
- \$20k- \$200k
- Up to 10 years to repay with zero interest
- Must be located within City of Santa Rosa
- Priority points for facilities located within QCTs
- Borrowers will submit Annual Use of Funds report through 2030 (# and demographics of children served)



#### Logistics

- July 2022 through December 2024
- First 5 will partner with Santa Rosa CBOs, schools, child care providers to outreach to and establish at least 2,000 ScholarShare 529 accounts for Santa Rosa children, birth to age five
- Household income must be 75k or less
- Prioritize outreach and enrollment of children living in QCTs
- Initial seed deposit = \$700
- Incentives to participate in Family Resource Center programs = 2 @ \$50
- City of Santa Rosa funding: \$1,575,000
- Leveraging with First 5 Sonoma County funding (Prop. 10 and CA Student Aid Commission)





#### **Desired Impacts**

- Inspire low-income parents to see college as accessible to their children
- Create a culture of **asset-building** for low and moderate income families
- Reduce financial stressors through coaching and financial supports offered by Family Resource Centers
- Increase racial and economic equity by expanding the pipeline of postsecondary education-bound students.
