### FIRST AMENDMENT TO BIOSOLIDS SPREADING AGREEMENT NUMBER F001493 WITH GILARDI & JACOBSEN AG SERVICES, INC.

This First Amendment to Agreement number F001493, dated August 31, 2017, ("Agreement") is made as of this 15<sup>th</sup> day of May, 2018, by and between the City of Santa Rosa, a municipal corporation ("City"), and Gilardi & Jacobsen Ag Services, Inc., a California Corporation ("Contractor").

#### RECITALS

- A. City and Contractor entered into the Agreement for terms pursuant to which Contractor provides Biosolids spreading services.
- B. City and Contractor now desire to amend the Agreement for the purpose of extending the term for one year and increasing Compensation.

#### AMENDMENT

**NOW, THEREFORE**, the parties agree to amend the Agreement as follows:

#### 1. TERM

Pursuant to Section 2 of the Agreement, the parties hereby agree to extend the term of the Agreement for an additional year, to October 31, 2018.

#### 2. COMPENSATION

2.1 Exhibit "B" to the Agreement is replaced by Exhibit "B-1" to this Amendment for rates for the Amendment term of one additional year.

2.2 Section 4 of the Agreement is amended to increase the compensation payable to Contractor under the Agreement as follows:

"The total of all fees paid to Contractor for the satisfactory performance and completion of all services set forth in Exhibit A shall not exceed the total sum of \$44,392.20. The Chief Financial Officer is authorized to pay all proper claims from Charge Number 130807-5321."

All other terms of the Agreement shall remain in full force and effect.
