

RESOLUTION NO. RES-2021-037

RESOLUTION OF THE COUNCIL OF THE CITY OF SANTA ROSA AUTHORIZING STAFF TO USE THE STATEWIDE CONTRACT NO. C4-CVD-19-001-03 BETWEEN CELLCO PARTNERSHIP DBA VERIZON WIRELESS AND THE CALIFORNIA DEPARTMENT OF TECHNOLOGY (CDT) FOR THE CONTINUED PURCHASE AND USE OF WIRELESS EQUIPMENT AND SERVICE THROUGH VERIZON WIRELESS FOR THE INITIAL AND EXTENSION TERMS ENDING MAY 22, 2027, FOR A TOTAL AMOUNT NOT TO EXCEED \$3,000,000 AND DELEGATION OF AUTHORITY TO THE CITY MANAGER TO EXECUTE NECESSARY DOCUMENTS

WHEREAS, Verizon Wireless has been used by the City as the primary provider of wireless devices and service since approximately 2004; and

WHEREAS, the Information Technology Department, and Police and Fire Departments through Information Technology's central account, purchase and support approximately 800 wireless devices for city staff use; and

WHEREAS, the City currently utilizes the Western States Contracting Alliance ("WSCA"), now known as NASPO ValuePoint, acting by and through the State of Nevada. The current contract (No. 1907), through the State of California Participating Addendum No. 7-10-70-16, is set to expire on March 31, 2021; and

WHEREAS, Cellco Partnership dba Verizon Wireless and the California Department of Technology (CDT) have entered into four-year statewide contract for CALNET Cellular Voice and Data Services, Contract No. C4-CVD-19-001-03 (CALNET Contract, attached hereto as Exhibit A), through May 22, 2023 with (2) 2-year extension options that, if both are exercised by the State would extend the Agreement through May 22, 2027; and

WHEREAS, all lines of service which were purchased on the City's account under the current contract and participating addendum, will be moved over to the new CALNET Contract; and

WHEREAS, the Information Technology Department recommends Council approve the use of the CALNET Contract between Cellco Partnership dba Verizon Wireless and the California Department of Technology (CDT), to continue procuring wireless devices and cellular service from Verizon Wireless, for the Contract's initial two year term, and contingent on CDT exercising its two, two-year options for in a total amount not to exceed \$3,000,000 through May 22, 2027.

NOW, THEREFORE, BE IT RESOLVED that the Council of the City of Santa Rosa authorizes staff to utilize CALNET Contract No. C4-CVD-19-001-03 for the continued purchase and use of wireless equipment and service through Cellco Partnership dba Verizon Wireless, for the Contract's initial two year term, and contingent on CDT exercising its two, two-year options for a total amount not to exceed \$3,000,000, through May 22, 2027.

BE IT FURTHER RESOLVED, that the Council of the City of Santa Rosa delegates authority to the City Manager or his designee to execute such agreements and documents that may be necessary to establish and execute cooperative purchases using the state's contract, including the Non-State Entity Service Policy and Agreement, the Authorization to Order and the Telecommunications Service Request (each of which are attached hereto as Exhibit A).
