eComment: City of Santa Rosa, CA Public Comment on Budget Priorities for the Fiscal Year 2021-2022 Budget Submitted to the City Clerk by Mark Walsh February 9, 2021 Agenda Item No. 15.1: I respectfully recommend that the City Council request a reconciliation of the graphical representation of changes in general fund balance presented for this budget priorities conversation with the audited changes in fund balances published by the City in its comprehensive annual financial reports. The variances are so significant that they distort an accurate portrayal of the general fund trends; and hamper a valid public conversation of budget priorities. The fund balance changes presented fiscal years 2005 through 2010 appear to be consistent between the audit reports and graphs. But significant differences exist for the most recent nine years. For the fiscal years 2011 through 2019, as audited, the aggregate change in fund balance is an increase of \$50 million. For the same periods, staff's presentation shows an aggregate increase; staff presented a \$2 million increase. The 2018 audit change is an \$8.5 million increase; staff presented a \$13 million decrease. The 2019 audit change is an increase of \$19 million; staff presented a \$4 million increase.
