

RESOLUTION NO. RES-2109-123

RESOLUTION OF THE COUNCIL OF THE CITY OF SANTA ROSA APPROVING A REVISED SCHEDULE OF PARKING USER FEES, APPROVING FREE PARKING IN CITY GARAGES ON CITY OBSERVED HOLIDAYS, AND APPROVING FREE SUNDAY PARKING IN THE 5<sup>TH</sup> STREET GARAGE AND THE D STREET GARAGE

WHEREAS, the City wishes to offer free parking in the five public garages on City observed holidays; and

WHEREAS, the City wishes to offer free parking on Sundays in Garage 3 (735 5<sup>th</sup> Street) and Garage 9 (97 D Street), between the hours of 3 a.m. and midnight.

NOW, THEREFORE, BE IT RESOLVED that the Council of the City of Santa Rosa finds and determines that the adoption of the fees set forth in Exhibit A is exempt from the requirements of the California Environmental Quality Act pursuant to Section 15378 of the CEQA Guidelines because it is not a project which has a potential for resulting in either a direct physical change in the environment, or a reasonable foreseeable indirect physical change in the environment.

BE IT FURTHER RESOLVED that the Council adopts the proposed Schedule of Parking User Fees, attached to this resolution as Exhibit A, pursuant to Chapter 11-24 of the Santa Rosa City Code and authorizes the Chief Financial Officer to implement the fees in accordance with Exhibit A.

BE IT FURTHER RESOLVED that the Council authorizes free parking in the five public garages on holidays between the hours of 3 a.m. and midnight as follows: New Year's Day (January 1<sup>st</sup>), Martin Luther King Day (3<sup>rd</sup> Monday in January), President's Day (3<sup>rd</sup> Monday in February), Memorial Day (last Monday in May), Independence Day (July 4<sup>th</sup>), Labor Day (1<sup>st</sup> Monday in September), Veteran's Day (November 11), Thanksgiving Day (4<sup>th</sup> Thursday in November) and Christmas Day (December 25).
