



CANNABIS PERMITTING UPDATE

3RD QUARTER

SEPTEMBER 12, 2017

The goal of this report is to track both the number and concentration of new medical cannabis businesses in Santa Rosa, and the impacts to other industries that occupy similar zoning. As the City of Santa Rosa implements new medical cannabis regulations, and permits new businesses within the city limits, understanding these impacts will inform policy development in the support of a diverse economy, and the retention of local businesses.

CANNABIS PERMITTING UPDATE

Under the City of Santa Rosa's interim cannabis policy, medical cannabis operators may locate in Light Industrial (IL), General Industrial (IG) and Business Park (BP) Zoning Districts. There are over 120 business types located within Santa Rosa's Industrial and Business Park zones, including sectors such as contractors, manufacturers, industrial rental services and supplies, as well as professional services such as legal and health care.

Santa Rosa has an approximate total of 10.3 million square feet of industrial space, with a vacancy rate of 5% (this has not changed substantially since the March 2017 report). At this time, the total square footage of **approved** medical cannabis space accounts for

3.0% of the total space available. This 3.0% represents 18 cannabis business (312,918 square feet) that have received their land use permit, two of which are currently in operation.

In addition to these 18 approved businesses, there are 33 additional cannabis businesses that have either gone through the pre-application process or have submitted an application for review. These 33 as yet unpermitted businesses in review represent an additional 4.8% (or 491,044 square feet) of Santa Rosa's total available industrial space.


CHART 3: Medical

(Pending/Approved)


CHART 4: Medical

(Pending/Approved)




