PUBLIC HEARING TO REVIEW EVIDENCE OF DEFAULT BY CORNERSTONE COMMUNITIES II, LLC ON THE PROPERTY LOCATED AT 410 B STREET, SANTA ROSA, CA APN 010-045-025 IN CONNECTION WITH THE AGREEMENT OF PURCHASE AND SALE FOR FUTURE INFILL DEVELOPMENT AND JOINT ESCROW INSTRUCTIONS

Notice is hereby given that a public hearing will be conducted by the City Council on Tuesday July 8, 2025, at or after 5:00 p.m. The purpose of the public hearing will be to receive public comment and recommendations prior to the City Council acting to consider whether to repurchase property located at 410 B Street, Santa Rosa, CA APN 010-045-025 pursuant to that certain Agreement of Purchase and Sale for Future Infill Development and Joint Escrow Instructions between the City and Cornerstone Communities II, LLC (the "Agreement"). The City has issued a notice of default of certain post-closing obligations under the Agreement. Under the terms of the Agreement, the City Council must hold a public hearing to consider evidence of the alleged defaults under the Agreement. A public hearing was held by City Council on December 10, 2024, and the Council issued a 120-day extension to April 10, 2025. On July 8, 2025, if the City Council determines that one or more material defaults did occur, the Council may elect to repurchase the Property for the Call Purchase Price of \$1,340,000, which is equal to the original purchase price under the Agreement.
