Ana Horta, Community Engagement Manager, gave a presentation and answered Member questions.

Jose Villagomez thanked the City of Santa Rosa for supporting the Celebrando Culturas Juntos, and made comments regarding the mission of the Children's Museum of Santa Rosa and its impact upon the City.

Tina Rogers made comments regarding her appreciation of the CAB, and the importance of helping and supporting children in the community.

Adina Flores made comments regarding her concerns about the remaining CAB grant funds, conflicts of interest she perceives with

the CAB member's grant approvals, her disagreement with the grant submission for the Children's Museum, and her stance against Measure I.

Duane DeWitt made comments regarding the grant amounts, the need to codify a waiting period for reapplying for a CAB grant, a previous experience when grant money was withdrawn from a project in Roseland, and suggested that grants be reserved for disadvantaged areas of the City.

Eric Fraser made suggestions to revise the confusing format of the grant applications, focused use of the grant funds to support those who are attempting to make the City better, and the establishment of a panel to direct grant funds.

## **6.2 MOTION - COMMUNITY ADVISORY BOARD GRANTS**

The Community Advisory Board (CAB) reviews and approves the 2024 Community Improvement Grant Applications. The Board shall award grants to the applicants whose projects best meet the criteria. Grant Applications for Quarter 3 closed on September 27, 2024. The CAB received 10 applications eligible for funding, totaling \$25,000.

**RECOMMENDATION:** It is recommended by the Communications and Intergovernmental Relations Department that the Community Advisory Board, by motion, determine the dispersing of Community Advisory Board Q3 2024 Grants.
