RE: NOTICE OF DENIAL OF APPLICATION FOR A TAXICAB DRIVER PERMIT

This is a notice of the denial of your application for a Taxicab Driver Permit filed with the Santa Rosa Police Department on September 3, 2014. The denial is made pursuant to Section 6-87.250 of the Santa Rosa City Code (SRCC). The facts supporting the denial of your application are as follows:

You have not taken and passed, with negative results, a controlled substance and alcohol test [SRCC Section 6-87.250(G)].

You have the right to appeal the denial of your application for a permit within fifteen (15) days after the date of this notice by requesting a hearing with the Chief of Police. Your request for a hearing must be in writing and shall state in general any facts upon which you object to the denial. (SRCC Sections 6-87.250(H); 6-87.480; 6-76.020.)

After reasonable notice to you, the Chief of Police, or the Chief's designee, will act as a hearing officer and shall convene a hearing of your appeal. At the hearing, you or your appointed representative may present evidence to rebut the findings and determinations made above. In addition, the hearing officer may receive and consider any other evidence which may bear upon the findings and determinations, provided you are given a reasonable opportunity to respond to all such evidence. (SRCC Section 6-76.030.)

Within thirty (30) days after the conclusion of the hearing, the Chief of Police shall mail a notice of decision to you and all other persons who participated in the hearing and requested such notice. The notice shall be in writing and shall state the decision as well as finding of fact which support the decision. (SRCC Section 6-76.040.)
