I'd like to see a setback of 1500 feet from ANY residence/school/day care facility/park/hiking trail/senior residence/senior center/hospital/rehab facility, and 1500 feet between WTFs. I'd also like to see continuous monitoring of wireless emissions by an independent contractor, with current real time results made available to the public 24/7 online. We need an automatic shutoff device that shuts off the WTF if emissions exceed a certain amount. If emissions exceed the maximum a 2nd time, the telecom company gets fined. If emissions exceed the maximum amount three times, the WTF must be removed within 30 days. In the meantime, all applications for WTFs must not be approved until this ordinance is passed.
