SANTA ROSA CITY COUNCIL MINUTES REGULAR MEETING CITY HALL, 100 SANTA ROSA AVENUE APRIL 9, 2013

1. CALL TO ORDER AND ROLL CALL

Vice Mayor Carlstrom called the meeting to order at 2:30 p.m. Council Members present: Vice Mayor Carlstrom, Council Members Combs, Olivares, Ours, Swinth, and Wysocky. Mayor Bartley was absent.

2. INTERVIEWS FOR BOARDS/COMMISSIONS/COMMITTEES

The City Council conducted an interview with Tom Brandon, who applied for reappointment to a labor representative position on the Personnel Board for a term ending on December 31, 2016.

3. ANNOUNCEMENT OF CLOSED SESSION ITEMS

3.2 RECESS TO CLOSED SESSION IN MAYOR'S CONFERENCE ROOM

Vice Mayor Carlstrom recessed the meeting to closed session at 2:45 p.m. in the Mayor's Conference Room.

3.3 CONFERENCE WITH LEGAL COUNSEL – ANTICIPATED LITIGATION

Significant exposure to litigation pursuant to subdivision (d)(2) of Government Code Section 54956.9: (one case regarding potential Sonoma County Landfill liability)

3.4 RECESS CLOSED SESSIONS AND RECONVENE TO OPEN SESSION IN THE COUNCIL CHAMBER

Vice Mayor Carlstrom reconvened the meeting to open session at 3:35 p.m. in the City Council Chamber.

4. STUDY SESSION

4.1 VULNERABLE USER PROTECTION

The Sonoma County Bicycle Coalition has prepared a draft ordinance related to the protection of bicyclists and pedestrians referred to as "vulnerable users" which it is requesting local jurisdictions to adopt. Staff has reviewed the draft ordinance and has proposed some modifications to the original draft ordinance presented by the Bicycle Coalition.

To date, the County of Sonoma, the cities of Sebastopol and Healdsburg have reviewed the draft ordinance. The proposed ordinance which staff is seeking input and direction on is similar to those approved in Sunnyvale and Berkeley and the County of Sonoma.

Paul Henry, Police Lieutenant, provided the staff report. Lieutenant Henry, City Attorney Fowler, and Gary Helfrich, Sonoma County Bicycle Coalition, responded to questions from Council members.

The Council concurred to direct staff to place consideration of the Vulnerable User Protection ordinance on a future Council agenda. No action was taken.

Vice Mayor Carlstrom recessed the meeting at 3:56 p.m. and reconvened the meeting at 4:02 p.m.

MOVED by Council Member Olivares, seconded by Council Member Ours, and carried 4-1-1-1 (Council Member Wysocky voting no, Council Member Combs abstaining, Mayor Bartley absent) to re-appoint Max Bridges as an at-large representative on the Personnel Board for a term to expire December 31, 2016.

11. CITY MANAGER'S/CITY ATTORNEY'S REPORTS

Assistant City Manager Phillips reported on a future agenda related to the PG&E cleanup of the First Street site and the landfill operating agreement.

11.1 MOTION – PROPOSED AMENDMENTS TO LEAGUE OF CALIFORNIA CITIES BYLAWS

Following Council discussion, it was **MOVED** by Council Member Wysocky, seconded by Council Member Swinth and carried 6-0-1 (Mayor Bartley absent) to defer this item to the April 16th City Council meeting to allow staff additional time to provide more information regarding the basis for the 2/3 voting requirement and its potential impact on Santa Rosa. The motion carried 6-0-1 (Mayor Bartley absent).

MOVED by Council Member Olivares and seconded by Council Member Ours to waive reading of the text and adopt Item 12.1 as follows:

12.1 MOTION – CONTRACT AMENDMENT - AUTOMOTIVE PARTS AND SUPPLIES

MOTION to approve Amendment No. 2 to Contract F000321 for additional funding for automotive parts and supplies to Smothers Parts International, Inc., Santa Rosa, California, in the amount of \$150,000.

Jim Wright, Purchasing Agent, responded to questions from Council.

The motion carried 6-0-1 (Mayor Bartley absent).

13. REPORT ITEMS

13.1 REPORT – AMENDING COUNCIL POLICY NO 000-26 -STATEMENT OF INVESTMENT POLICY AND DELEGATING AUTHORITY

BACKGROUND: Council Policy No. 000-26 - Statement of Investment Policy, was adopted to specify the policies and procedures that support a prudent and systematic program for the investment of public funds. The policy was last revised in September 2011. Staff, in conjunction with the City's Investment Advisor, PFM Asset Management, has reviewed the current policy and is recommending a number of revisions to update and enhance the policy.

RECOMMENDATION: It is recommended by the Finance Department that the Council, by resolution, amend Council Policy No. 000-26 - Statement of Investment Policy, as revised, and delegate the investment authority to the Chief Financial Officer.

Jean Gill, Budget and Financial Analyst Manager, Arvin Look, Financial Analyst, and Lauren Brant, Managing Director of PFM Asset Management LLC, provided the staff report and responded to questions from Council members. Chief Financial Chiu also responded to questions from Council members.

MOVED by Council Member Olivares, seconded by Council Member Ours, to waive reading of the text and adopt:

RESOLUTION NO. <u>28260</u> ENTITLED: RESOLUTION OF THE COUNCIL OF THE CITY OF SANTA ROSA AMENDING COUNCIL POLICY NO 000-26 - STATEMENT OF INVESTMENT POLICY AND DELEGATING AUTHORITY

Following Council discussion, it was moved by Council Member Wysocky and seconded by Council Member Combs to table the main motion. The motion failed 2-4-1 (Vice Mayor Carlstrom, Council Members Olivares, Ours and Swinth voting no and Mayor Bartley absent.)

Following Council discussion Council Member Swinth proposed a friendly amendment to the main motion to include direction to staff to follow up with a report regarding community banking, specifically to include information as to how the 15% plays out in the community and the percentage of the City's assets that might be locally invested when looking at banks and credit unions in the area at a \$250,000 Certificate of Deposit level. The friendly amendment was accepted by the maker and seconder of the motion and the main motion as amended carried 4-2-1 (Council Members Combs and Wysocky voting no and Mayor Bartley absent).

Vice Mayor Carlstrom recessed the meeting at 5:40 p.m. and reconvened the meeting at 5:48 p.m.

In response to questions from Council, Chief Financial Officer Chiu indicated information requested by Council under Item 13.1 will be brought back to Council after the June budget hearings.

13.2 REPORT – AUTHORIZATION OF INVESTMENT OF MONIES IN THE LOCAL AGENCY INVESTMENT FUND

BACKGROUND: The Local Agency Investment Fund (LAIF) requires a resolution authorizing City staff and their successors in office, to deposit and withdraw monies. Transactions with LAIF by authorized signers are subject to secure controls, that limit the deposit or withdrawal of funds to only designated (previously authorized) City and LAIF accounts. The City has made changes to several staff and position titles, making it necessary to update our records with LAIF.

RECOMMENDATION: It is recommended by the Finance Department that the Council, by resolution, authorize the Chief Financial Officer, Budget and Financial Analysis Manager, Administrative Services Officer (Finance Department), and Financial Analyst, to order the deposit or withdrawal of monies in the State of California Local Agency Investment Fund.

Arvin Look, Financial Analyst, provided the staff report and responded to questions from Council members.

MOVED by Council Member Ours and seconded by Council Member Olivares to waive reading of the text and adopt:

RESOLUTION NO. <u>28261</u> ENTITLED: RESOLUTION OF THE COUNCIL OF THE CITY OF SANTA ROSA AUTHORIZING INVESTMENT OF MONIES IN THE LOCAL AGENCY INVESTMENT FUND

The motion carried 6-0-1 (Mayor Bartley absent).

13.3 REPORT – AMENDMENT TO SANTA ROSA CITY CODE CHAPTERS 3-08, PURCHASING POLICY, AND 3-44, PUBLIC WORKS CONTRACT POLICY

BACKGROUND: City Code 3-08 Purchasing Policy establishes the policy for the purchase of supplies, material, equipment, and non-professional services, and defines the authority of the purchasing function, and was last updated in 2000. City Code 3-44 Public Works Contract Policy establishes the policy for letting public works contracts, and was last updated in 2003. A Purchasing Task Force, which included representatives from the City Attorney's Office, for advisory purposes, and all City departments that use purchasing services, was convened with the goal of examining and making recommendations to streamline the purchasing process. The above City Codes, the City Charter, and Purchasing procedures were reviewed during regularly scheduled meetings, processes were mapped, and recommendations were formulated by the Task Force members. As part of the City Code review process, changes are also recommended to update the language, and to make it more current, concise and clear.

RECOMMENDATION: It is recommended by the Finance Department that the Council introduce an ordinance amending certain sections of City Code Chapters 3-08, Purchasing Policy, and 3-44, Public Works Contract Policy, to incorporate changes recommended by the Purchasing Task Force, and to make the Chapters more current, concise and clear.

Jim Wright, Purchasing Agent, provided the staff report and responded to questions from Council members.

MOVED by Council Member Swinth and seconded by Council Member Olivares to waive reading of the text and introduce:

ORDINANCE ENTITLED: ORDINANCE OF THE COUNCIL OF THE CITY OF SANTA ROSA AMENDING CERTAIN SECTIONS OF CHAPTERS 3-08 PURCHASING POLICY, AND 3-44 PUBLIC WORKS CONTRACT POLICY OF THE SANTA ROSA CITY CODE

Following Council discussion, the motion carried 6-0-1 (Mayor Bartley absent).

13.4 REPORT – AMENDMENTS TO COUNCIL POLICY 000-40 - LEGISLATIVE ADVOCACY

BACKGROUND: The proposed amendments to Council Policy 000-40 (1) merge the Council Policy and Legislative Principles and Priorities into one document; (2) incorporate the Council's current priorities, goals and objectives as legislative priorities; and (3) reflect the Council's current procedure for responding to State and Federal legislation.

RECOMMENDATION: It is recommended by the City Manager's Office that the Council, by resolution, amend Council Policy 000-40 - Legislative Advocacy.

Jennifer Phillips, Assistant City Manager, provided the staff report and responded to questions from Council members.

MOVED by Council Member Combs and seconded by Council Member Swinth to waive reading of the text and adopt:

RESOLUTION NO. <u>28262</u> ENTITLED: RESOLUTION OF THE COUNCIL OF THE CITY OF SANTA ROSA AMENDING COUNCIL POLICY 000-40 - LEGISLATIVE ADVOCACY

The motion carried 6-0-1 (Mayor Bartley absent).
