RESOLUTION OF THE COUNCIL OF THE CITY OF SANTA ROSA ACCEPTING AN AWARD FOR \$1,693,820.00 FROM THE BOARD STATE AND COMMUNITY CORRECTIONS (BSCC) PROPOSITION 47 GRANT PROGRAM AND APPROVING THE STANDARD AGREEMENT WITH THE STATE OF CALIFORNIA DEPARTMENT OF GENERAL SERVICES AND APPROPRIATION OF FUNDS

WHEREAS, on June 18, 2025, the City of Santa Rosa Police Department applied for the Proposition 47 (Prop 47) Grant; and

WHEREAS, on September 11, 2025, notification was received that the City of Santa Rosa was awarded a grant in the amount of \$1,693,820.00 for the Proposition 47 (Prop 47) Grant for the period October 1, 2025, through June 30, 2029; and

WHEREAS, the funding in the amount of \$1,693,820.00 will be used to address critical gaps in healthcare access, mental health services, and supportive resources for individuals with mental health and/or substance use disorders, who are underserved and/or experiencing homelessness in Santa Rosa. These funds will be used by the inRESPONSE Mental Health and Support Team to follow up on all crisis response van contacts within 72-hours, a key responsibility for required Medi-Cal billing and help ensure future funding.

NOW, THEREFORE, BE IT RESOLVED that the Council of the City of Santa Rosa accepts grant funds in the amount of \$1,693,820 from the Board State and Community Corrections (BSCC) through the Proposition 47 Grant Program.

BE IT FURTHER RESOLVED that the Council approves the Standard Agreement with the State of California Department of General Services, subject to approval as to form by the City Attorney.

BE IT FURTHER RESOLVED that the Council authorizes the City Manager or designee to execute award documents and any and all other documents for the award with the Board State and Community Corrections, subject to approval as to form by the City Attorney.
