

**SECOND AMENDMENT  
TO GENERAL SERVICES AGREEMENT NUMBER F001450  
WITH SYAR INDUSTRIES, INC.**

This Second Amendment to Agreement number F001450, dated July 11, 2017 ("Agreement") is made as of this \_\_\_\_\_ day of \_\_\_\_\_, 2019, by and between the City of Santa Rosa, a municipal corporation ("City"), and Syar Industries, Inc., a California Corporation ("Contractor").

**RECITALS**

- A. City and Contractor entered into the Agreement for Contractor to provide concrete supplies. The First Amendment extended the contract.
- B. City and Contractor now desire to amend the Agreement for the purpose of extending the term of the Agreement for an additional year and increasing compensation.

**AMENDMENT**

**NOW, THEREFORE**, the parties agree to amend the Agreement as follows:

1. **SCOPE OF SERVICES**

Effective July 12, 2019, Exhibit B to the Agreement is replaced by Exhibit B-1 to this Amendment.

2. **TERM, SUSPENSION, TERMINATION**

Pursuant to Section 6(a) of the Agreement, the parties hereby agree to extend the term of the Agreement for an additional year.

3. **COMPENSATION**

Section 4 of the Agreement is amended to increase the compensation payable to Contractor under the Agreement by \$200,000 to read as follows:

"The total of all fees paid to Contractor for the satisfactory performance and completion of all services set forth in the Agreement shall not exceed the total sum of \$965,391.55. The Chief Financial Officer is authorized to pay all proper claims from various department charge numbers."

All other terms of the Agreement shall remain in full force and effect.
