RESOLUTION OF THE COUNCIL OF THE CITY OF SANTA ROSA AUTHORIZING A GRANT APPLICATION TO THE CALIFORNIA DEPARTMENT OF TRANSPORTATION FOR FEDERAL FUNDING UNDER THE FEDERAL TRANSIT ACT (49 U.S.C. § 5310)

WHEREAS, the U.S. Department of Transportation is authorized to make grants to states through the Federal Transit Administration to support capital projects for public transportation systems under Section 5310 of the Federal Transit Act (49 U.S.C., Chapter 53); and

WHEREAS, the California Department of Transportation (Department) has been designated by the Governor of the State of California to administer Section 5310 grants for transportation projects for seniors and individuals with disabilities; and

WHEREAS, the City of Santa Rosa (Subrecipient) desires to apply for said financial assistance to permit operation of transportation service in the City of Santa Rosa; and

WHEREAS, the City of Santa Rosa has, to the maximum extent feasible, coordinated with other transportation providers and users in the region (including social service agencies); and

WHEREAS, no non-profit agency or organization present or in writing expressed an interest to apply for Section 5310 funding for transportation for seniors and to individuals with disabilities; and

WHEREAS, a notice of Public Hearing to this resolution confirms that the City of Santa Rosa conducted a Public Hearing on Tuesday, February 14, 2017 at or after 5:00 p.m., in the City Council Chamber, City Hall, 100 Santa Rosa Avenue, Santa Rosa, to determine if there were any private or non-profit businesses or agencies available to provide transportation services to meet the needs of senior or disabled individuals where public transportation services are otherwise unavailable, insufficient or inappropriate.

NOW, THEREFORE, BE IT RESOLVED that no non-profit agencies expressed an interest in applying for Section 5310 funding to provide transportation services to meet the needs of seniors and individuals with a disability before or at the public hearing.

BE IT FURTHER RESOLVED by the Council of the City of Santa Rosa that the Council does hereby authorize the City Manager or his designated representative to file and execute applications on behalf of the City of Santa Rosa with the California Department of Transportation to aid in the financing of capital projects pursuant to Section 5310 of the Federal Transit Act.

BE IT FURTHER RESOLVED that the City Manager or his designated representative is authorized to execute and file all certification of assurances, contracts and agreements and any other document required by the California Department of Transportation.

BE IT FURTHER RESOLVED that the City Manager or his designated representative is authorized to provide additional information as the California Department of Transportation may

require in connection with the application for the Section 5310 projects.

BE IT FURTHER RESOLVED that the City Manager or designated representative is authorized to submit and approve requests for reimbursement of funds from the California Department of Transportation for the Section 5310 projects.
