

**CITY OF SANTA ROSA**  
**2019 Report of Diversity of City Council Appointees**

Section 11 of the City of Santa Rosa’s Charter requires an annual report on the diversity of Council appointments for boards, commissions, and committees. Additionally, Section 11 states, “The report shall contain, but is not limited to, the total number of appointments in a given year, the total number of applications in a given year, and relevant diversity information including geographic and ethnic diversity. Further, the report will evaluate the progress and success of increasing the diversity of appointments.”

In addition to the specified requirements, this report includes data on gender diversity<sup>1</sup>.

The table below lists the bodies included in the report with the overview of applications received in 2019 and appointments made in 2019.

- 96% of Applicants (53 out of 55) reported gender information

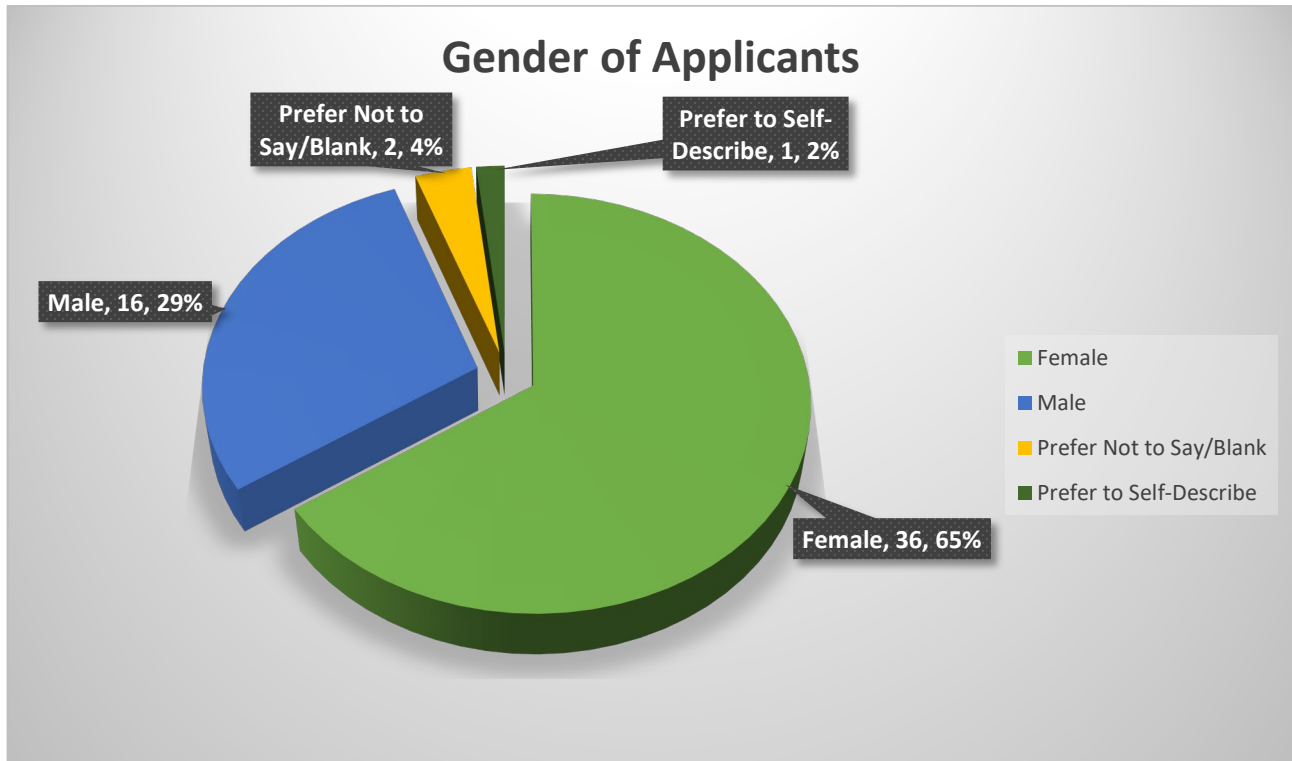
Applicants may submit multiple applications, therefore applications received may be higher than applicants. Total applications received (67), Total unique applicants (55)

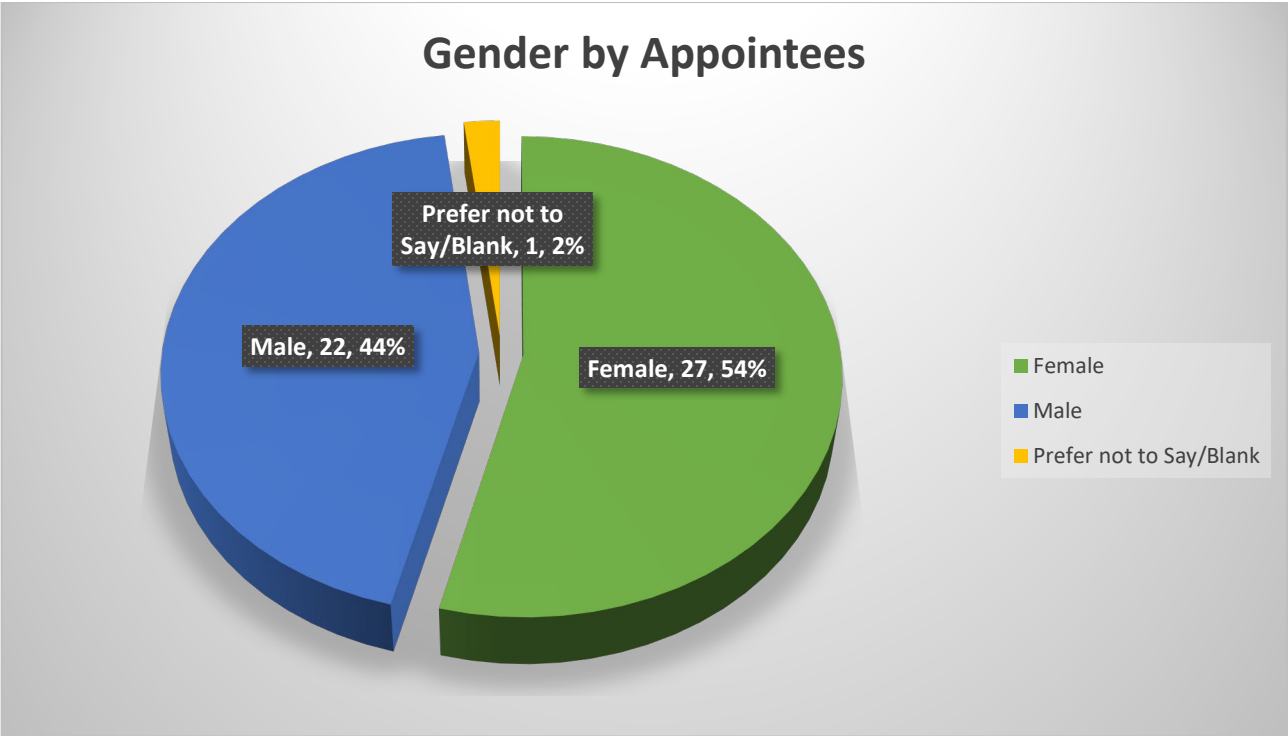
**Gender – Applicants (55)**

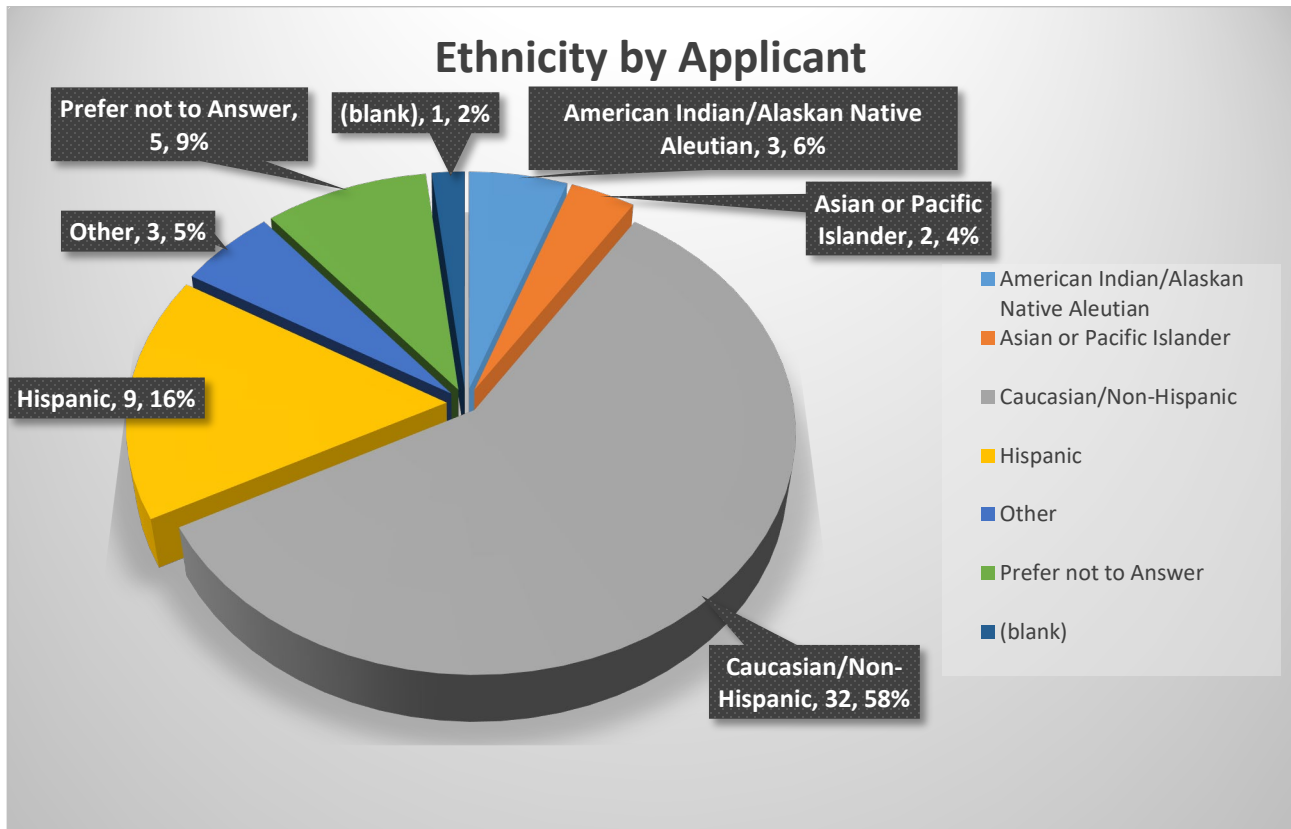

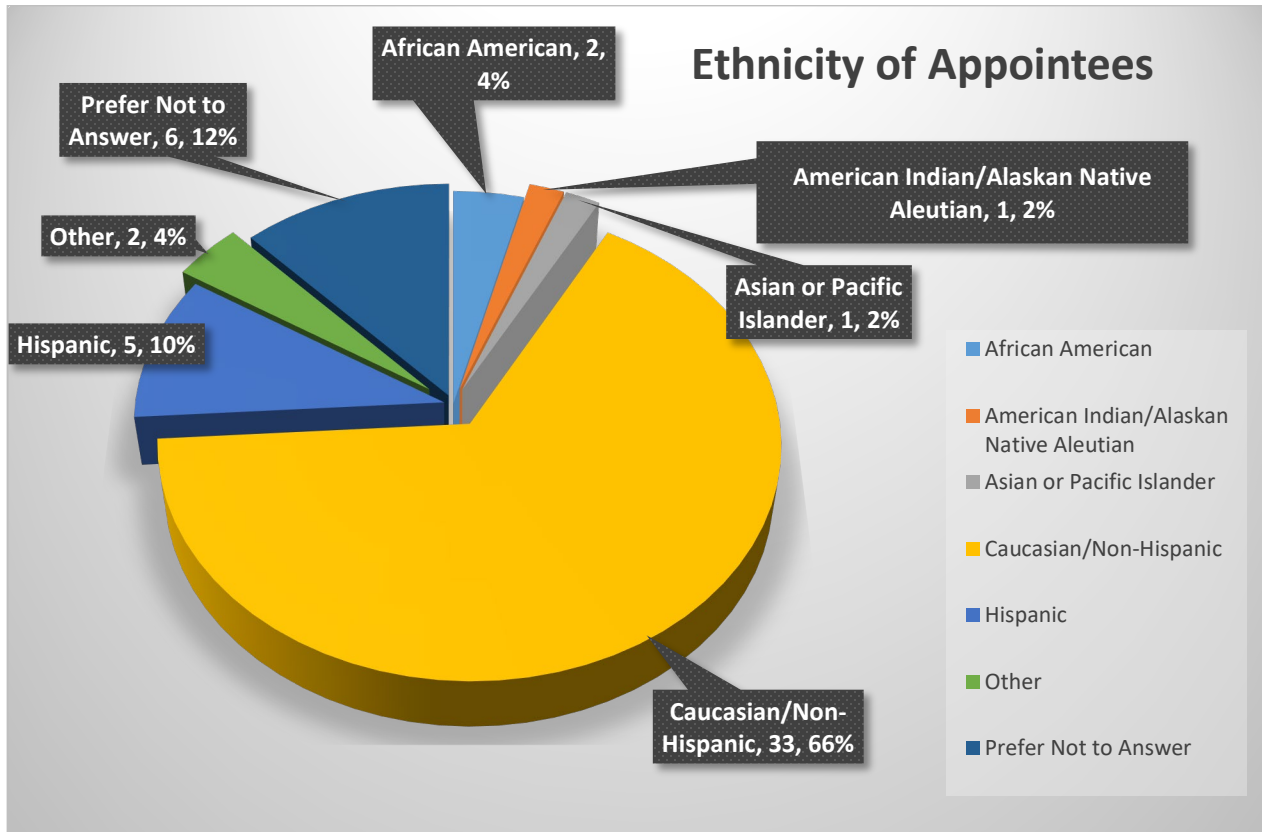

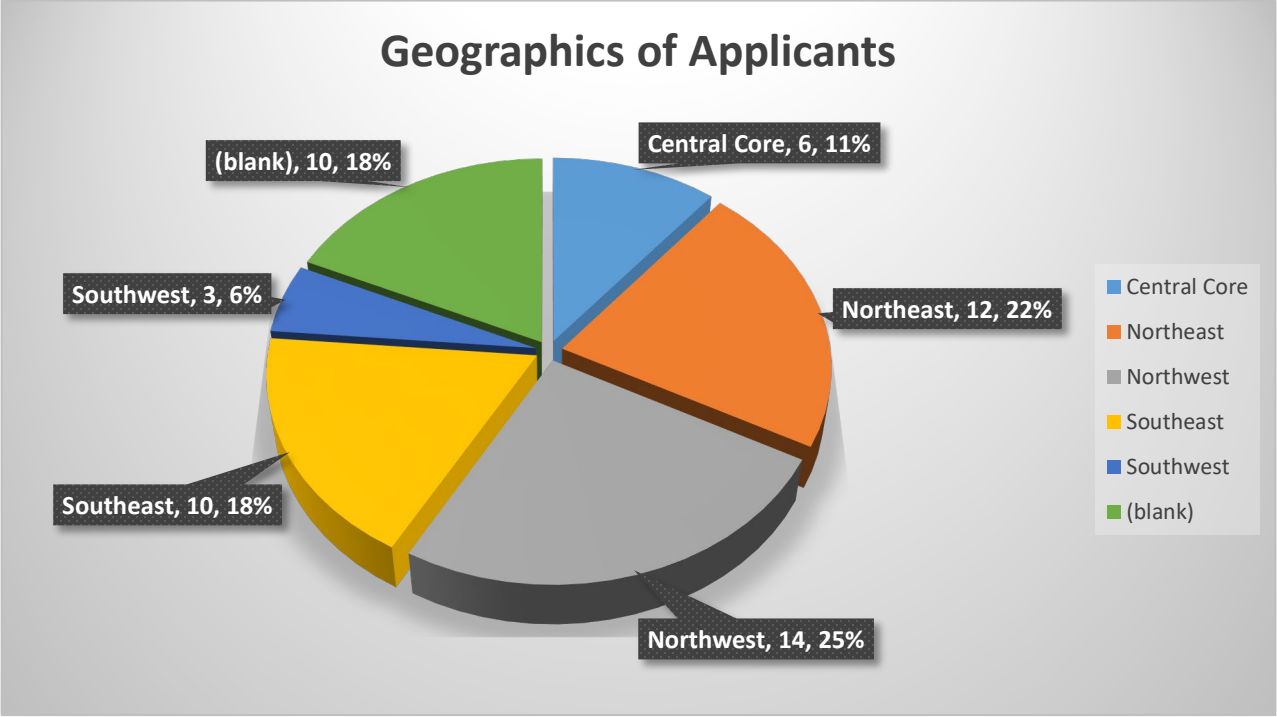

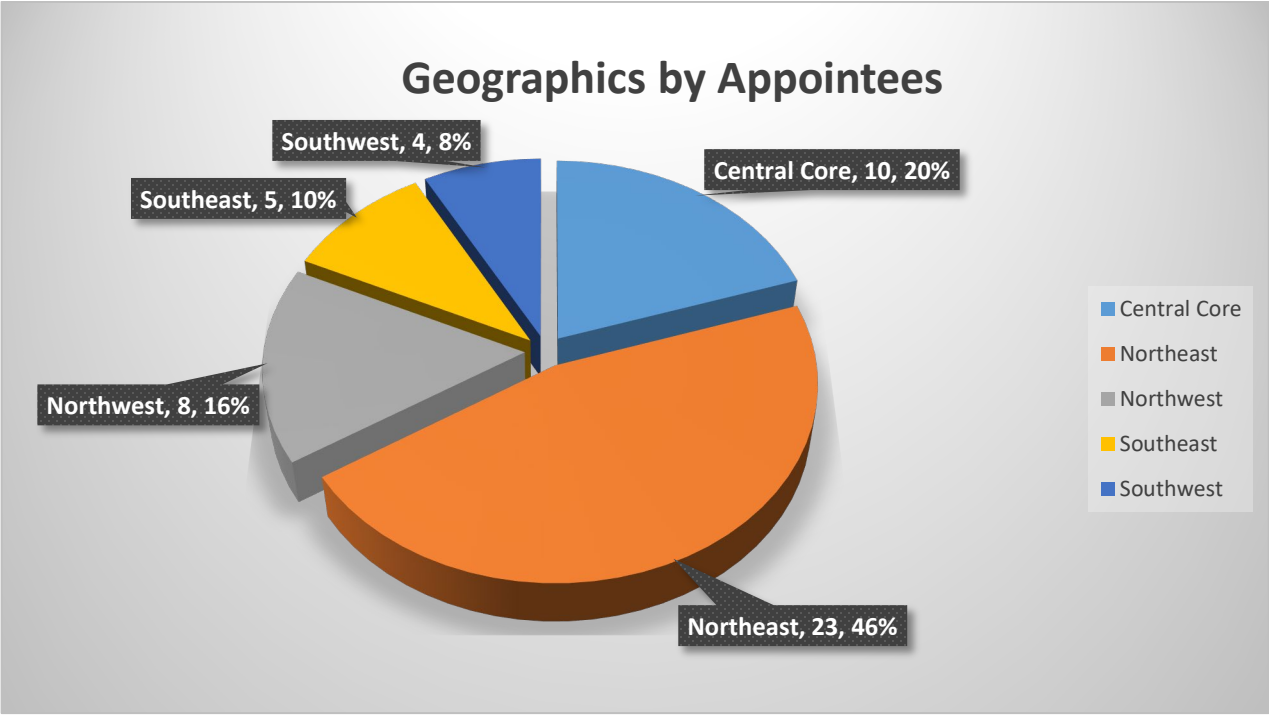

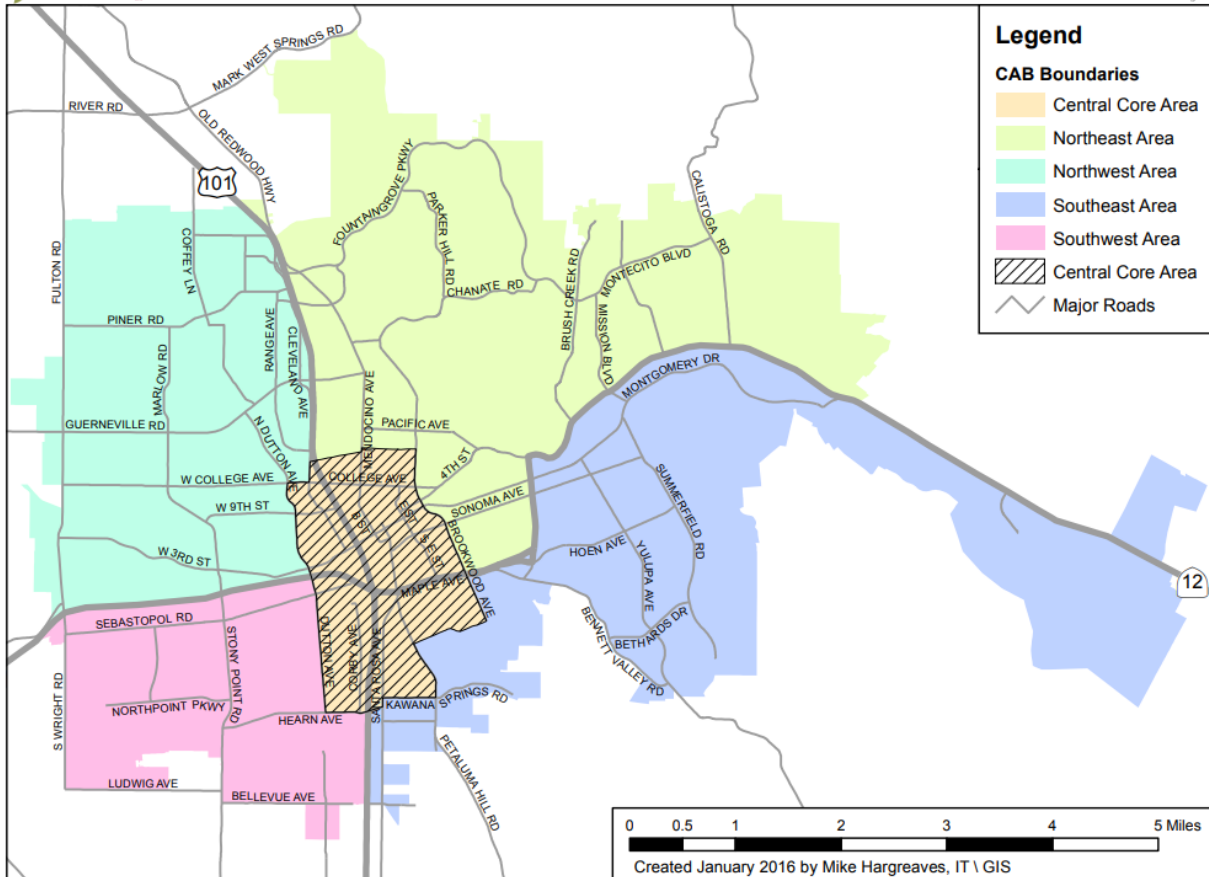
