## RESOLUTION NO. 28779

RESOLUTION OF THE COUNCIL OF THE CITY OF SANTA ROSA AUTHORIZING THE TEMPORARY WAIVER OF PARKING FEES IN THE CENTRAL PARKING DISTRICT ON FRIDAY, MAY 20, 2016, AND SATURDAY, MAY 21, 2016, SPECIFICALLY IN THE AREAS BETWEEN BROOKWOOD AVENUE, B STREET, SEVENTH STREET, AND SONOMA AVENUE, AND INCLUDING PARKING GARAGES 5 AND 9, AND SURFACE LOTS 2, 7, AND 11 FOR THE LUTHER BURBANK ROSE PARADE AND THE AMGEN TOUR OF CALIFORNIA

WHEREAS, on Saturday, May 21, 2016, the City will host the joint production of the 11th annual Amgen Tour of California and the 122nd Luther Burbank Rose Parade; and

WHEREAS, the production of these events will have a substantial impact on public access to metered parking, parking lots, and Garages 5 and 9 within the Central Parking District; and

WHEREAS, the Local Organizing Committees of the Amgen Tour of California and the Luther Burbank Rose Parade are seeking the temporary waiver of parking fees, including fees imposed pursuant to City Code sections 11-24.030, 11-24.040, 11-24.050, and 11-24.100, in the Central Parking District on Friday, May 20, 2016, and Saturday, May 21, 2016, in the areas affected by the Luther Burbank Rose Parade and the Amgen Tour of California; and

WHEREAS, the waiver of enforcement and fees for Friday, May 20, 2016, include the metered spaces on 3<sup>rd</sup> Street between Santa Rosa Avenue and D Street, Mendocino Avenue between 1<sup>st</sup> and 7<sup>th</sup> Streets, and D Street between 2<sup>nd</sup> and 3<sup>rd</sup> Streets; and

WHEREAS, the waiver of enforcement and fees for Saturday, May 21, 2016, include the street meters that are within the area surrounded by Brookwood Avenue, Sonoma Avenue, B Street, and Seventh Street, and for the surface parking lots 2, 7, and 11, and finally for the parking garages 5 and 9.

NOW, THEREFORE, BE IT RESOLVED that the Council of the City of Santa Rosa authorizes the temporary waiver of parking fees for the Luther Burbank Rose Parade and the Amgen Tour of California, including fees imposed pursuant to City Code sections 11-24.030, 11-24.040, 11-24.050, and 11-24.100, in the Central Parking District as follows:

1) On Friday, May 20, 2016 a waiver to include metered spaces on 3<sup>rd</sup> Street between Santa Rosa Avenue and D Street, Mendocino Avenue between 1<sup>st</sup> and 7<sup>th</sup> Streets, and D Street between 2<sup>nd</sup> and 3<sup>rd</sup> Streets.

2) On Saturday, May 21, 2016, a waiver in the area bounded by Brookwood Avenue, B Street, Seventh Street, and Sonoma Avenue, and including parking garages 5 and 9, and surface lots 2, 7, and 11.
