BACKGROUND: Storybrook Village Preschool provides a year-round, day care program serving children 18-months to 6-years of age.

Proposed hours of operation are Monday-Friday, 7:30 am to 5:00 pm, and will service a maximum of 24 children. The existing structure was originally designed as a preschool and no modifications are proposed. The project is exempt from the California Environmental Quality Act (CEQA).
