A total settlement amount of \$2,999,999.99 was agreed to in exchange for a release of all claims, with the City paying approximately \$900,000 of that amount and the City's risk pool, CJPRMA, paying the rest. The incident that led to this lawsuit involved SRPD responding to an active shooter in a residential neighborhood. The settlement followed a district court's ruling exonerating 4 of the 5 SRPD members named in the lawsuit, determining that SRPD's policies and practices were lawful, and concluding that only the actions of 1 officer were appropriate for trial.
