

**TENTH AMENDMENT  
TO GENERAL SERVICES AGREEMENT  
WITH GOLDEN GATE LANDSCAPE MANAGEMENT INC.  
AGREEMENT NUMBER F000799**

This Tenth Amendment to Agreement number F000799, dated August 5, 2014 ("Agreement") is made as of this \_\_\_\_\_ day of \_\_\_\_\_, 2018, by and between the City of Santa Rosa, a municipal corporation ("City"), and Golden Gate Landscape Management Inc., a California Corporation ("Contractor").

**RECITALS**

- A. City and Contractor entered into the Agreement for Contractor to provide landscape maintenance services, as previously amended by the First through Ninth Amendments to adjust service sites and compensation.
- B. City and Contractor now desire to amend the Agreement for the purposes of prohibiting the use of Glyphosate to perform services, extending the term of the Agreement for one year with no increase to contract rates, and increasing compensation.

**AMENDMENT**

**NOW, THEREFORE**, the parties agree to amend the Agreement as follows:

**1. SCOPE OF SERVICES**

Notwithstanding anything in the Agreement or exhibit to the Agreement to the contrary, Contractor shall not use pesticides or herbicides that contain Glyphosate in the performance of the Scope of Services under this Agreement.

**2. COMPENSATION**

Section 4 of the Agreement is amended to increase the compensation payable to Contractor under the Agreement by \$549,789.84 to read as follows:

"The total of all fees paid to Contractor for the satisfactory performance and completion of all services set forth in the Agreement shall not exceed the total sum of \$2,579,337.18. The Chief Financial Officer is authorized to pay all proper claims from Various Charge Numbers."

**3. TERM, SUSPENSION, TERMINATION**

Pursuant to Section 6(a) of the Agreement, the parties hereby agree to extend the term of the Agreement for one year.

All other terms of the Agreement shall remain in full force and effect.
