RESOLUTION OF THE COUNCIL OF THE CITY OF SANTA ROSA APPROVING COOPERATIVE AGREEMENT NUMBER 04-3020 BETWEEN THE STATE OF CALIFORNIA, ACTING THROUGH ITS DEPARTMENT OF TRANSPORTATION (CALTRANS), AND THE CITY OF SANTA ROSA AUTHORIZING CALTRANS TO PROVIDE QUALITY MANAGEMENT ASSESSMENT OF CONSTRUCTION ACTIVITIES FOR THE HIGHWAY 101 BICYCLE AND PEDESTRIAN OVERCROSSING PROJECT AND DELEGATING AUTHORITY TO THE CITY MANAGER TO NEGOTIATE AND EXECUTE THE AGREEMENT

WHEREAS, the City of Santa Rosa (City) would like to construct a pedestrian and bicycle bridge overcrossing US Highway 101 (Project) to include a 5-foot-wide sidewalk and an 8-foot-wide bike path, which will provide a much-needed improvement to the existing pedestrian and bicycle connectivity, and reduce pedestrian/vehicle conflict, and improve more opportunities for alternative transportation; and

WHEREAS, Caltrans has requested that the City adopt a resolution approving and authorizing the execution of a Cooperative Agreement for Construction in conformance with Caltrans' project development process to advance the Project; and

WHEREAS, Cooperative Agreement Number 04-3020 between the City and Caltrans for the Hwy 101 Bike and Pedestrian Overcrossing project is necessary in order to establish agency responsibilities, terms and conditions during construction activities.
