RECITALS

- A. City and Contractor entered into the Agreement for Contractor to provide repair and maintenance services to firefighting ensembles, as previously amended.
- B. City and Contractor now desire to amend the Agreement for the purpose of extending the term for two years with an average 0.53% increase in unit cost and increasing compensation.

<u>AMENDMENT</u>

NOW, THEREFORE, the parties agree to amend the Agreement as follows:

1. BILLABLE RATES, PAYMENTS TO CONTRACTOR

Exhibit A to the Agreement is replaced by Exhibit A-1 to this Amendment, and Section 5(a) of the Agreement is amended to read as follows:

- "a. Billable rates. Contractor shall be paid for the performance of service as set forth in Exhibit A-1."
- 2. TERM, SUSPENSION, TERMINATION

Pursuant to Section 6(a) of the Agreement, the parties hereby agree to extend the term of the Agreement for an additional two years.

COMPENSATION

Section 4 of the Agreement is amended to increase the compensation payable to Contractor under the Agreement by \$150,000.00 to read as follows:

"The total of all fees paid to Contractor for the satisfactory performance and completion of all services set forth in the Agreement shall not exceed the total sum of \$245,000. The Chief Financial Officer is authorized to pay all proper claims from Charge Number 060200-5341."

4. COUNTERPARTS AND ELECTRONIC SIGNATURES

Section 22 (Counterparts and Electronic Signatures) is added to the Agreement after Section 21 (Authority; Signatures Required for Corporations) as follows:

"Section 22. COUNTERPARTS AND ELECTRONIC SIGNATURES."

This Agreement and future documents relating thereto may be executed in two or more counterparts, each of which will be deemed an original and all of which together constitute one Agreement. Counterparts and/or signatures delivered by facsimile, pdf or City-approved electronic means have the same force and effect as the use of a manual signature. Both City and Contractor wish to permit this Agreement and future documents relating thereto to be electronically signed in accordance with applicable federal and California law. Either Party to this Agreement may revoke its permission to use electronic signatures at any time for future documents by providing notice pursuant to the Agreement. The Parties agree that electronic signatures, by their respective signatories are intended to authenticate such signatures and to give rise to a valid, enforceable, and fully effective Agreement. The City reserves the right to reject any digital signature that cannot be positively verified by the City as an authentic electronic signature."

All other terms of the Agreement shall remain in full force and effect.
