The reduction applies to all fees associated with services provided by the Planning, Building and Engineering Divisions within Planning and Economic Development.	50% of published rate

The reduction applies to all fees associated with permits and services provided by the Building and Engineering Divisions within the Planning and Economic Development Department.	50% of published rate
Homeowner Submitted Landmark Alteration (LMA) Permits Any Landmark Alteration Permit application submitted by a homeowner as the applicant. The 92% reduction applies to Director Level LMA, Minor LMA, Major LMA, Amendment to Minor LMA, and Amendments to Major LMA Permits. There shall be no fee for a homeowner submitted Concept LMA review.	92% of published rate (no charge for Concept LMA)
