NINTH AMENDMENT TO GENERAL SERVICES AGREEMENT NUMBER F000633 WITH PETRUSHA ENTERPRISES, INC. dba ADVANCED SECURITY SYSTEMS

This Ninth Amendment to Agreement number F000633, dated October 1, 2013 ("Agreement") is made as of this 19th day of September, 2017, by and between the City of Santa Rosa, a municipal corporation ("City"), and Petrusha Enterprises, Inc. dba Advanced Security Systems, a California Corporation, ("Contractor").

RECITALS

- A. City and Contractor entered into the Agreement for Contractor to provide alarm monitoring, installation and repair services, as previously amended by the First through Eighth Amendments to adjust locations receiving services and adjust compensation.
- B. City and Contractor now desire to amend the Agreement for the purpose of extending an additional year, modifying sites services with compensation and adding compensation for miscellaneous installations and repairs.

AMENDMENT

NOW, THEREFORE, the parties agree to amend the Agreement as follows:

1. TERM, SUSPENSION, TERMINATION

Pursuant to Section 6(a) of the Agreement, the parties hereby agree to extend the term of the Agreement for one additional year.

2. SCOPE OF SERVICES

Exhibit B-1 to the Sixth Amendment is replaced in its entirety by Exhibit B-2 to the Ninth Amendment.

COMPENSATION

Section 4 of the Agreement is amended to increase the compensation payable to Contractor under the Agreement by \$57,000.00 to read as follows:

"The total of all fees paid to Contractor for the satisfactory performance and completion of all services set forth in the Agreement shall not exceed the

total sum of \$156,883.50. The Chief Financial Officer is authorized to pay all proper claims from Various Charge Numbers."

4. NOTICES

All other terms of the Agreement shall remain in full force and effect.
