

RESOLUTION NO. RES-2022-101

RESOLUTION OF THE COUNCIL OF THE CITY OF SANTA ROSA APPROVING THE FOURTH AMENDMENT TO THE SOLID WASTE COLLECTION SERVICES AGREEMENT BETWEEN THE CITY OF SANTA ROSA AND RECOLOGY SONOMA MARIN, DBA RECOLOGY SANTA ROSA

WHEREAS, on August 29, 2017, the Council approved the Solid Waste Collection Services Agreement (Agreement) between the City of Santa Rosa and Recology Sonoma-Marín, dba Recology Santa Rosa, to provide the City's garbage, recyclable material and organic waste collection services through Council Resolution No. RES-2017-172; and

WHEREAS, on December 19, 2017, the Council approved the First Amendment to the Agreement, implementing a low-income discount program under the Agreement through Council Resolution No. RES-2017-250; and

WHEREAS, on September 25, 2018, the Council approved the Second Amendment to the Agreement, bringing up-to-date certain refuse rate indices and Bureau of Labor Statistics data and revising the time periods used to determine service recipient rate adjustments under the Agreement through Council Resolution No. RES-2018-163; and

WHEREAS, on May 7, 2019, the Council approved the Third Amendment to the Agreement, adding infrequent service rates, reallocating several operating costs in the Refuse Rate Index, and correcting typographical errors in Section 10.07.13.2 and Section 13.04 under the Agreement through Council Resolution No. RES-2019-051; and

WHEREAS, SB 1383 became effective on January 1, 2022, and is a statewide effort to reduce organic waste recycling and recover edible food to be donated to provide food for people in need; and

WHEREAS, the parties would like to further amend the Agreement to assist City in complying with SB 1383 Regulations.
