RECOMMENDATION

It is recommended by the Finance Department that the Council, by resolution, authorize the City Manager or Assistant City Manager in connection with Community Development Block Grant (CDBG) Mitigation (MIT) Planning and Public Services (PPS) projects developed in response to the 2017 Tubbs Fire, to enter into, execute and/or deliver the following: 1) the Standard Agreement and any and all subsequent amendments thereto with the State of California for the Grant; 2) all project applications and any and all related documentation related to the Agreement and to act on the City's behalf in all matters pertaining to all such applications and documentation; 3) all Notice(s) to Proceed, and any and all subsequent amendments thereto, if a grant application is approved; and 4) Funds Requests and all required reporting forms and other documentation as may be required for the Grant.

EXECUTIVE SUMMARY

The City has developed projects that fit within the criterion of Community Development Block Grant Mitigation Planning and Public Services Program. However, prior to entering into any agreement with HCD, the City must approve an HCD authorizing resolution, granting certain city staff the authority to enter into those agreements. Staff recommends delegating authority to the City Manager or Assistant City Manager with the resolution.

BACKGROUND/ANALYSIS

HCD requires the City of Santa Rosa to approve an authorizing resolution to grant city staff the ability to sign grant applications and other forms relative to CDBG-MIT PPS program specifically developed in response to the 2017 Tubbs Fire disaster.

The City recently approved an authorizing resolution for CDBG-DR and CDBG-MIT programs; however, because this is a specific program within CDBG-MIT, the City must approve another authorizing resolution the PPS program.

Under the PPS program, the City received \$1,000,000 for two projects: The City-wide Storm Drain Master Plan (SDMP) for \$500,000, and the Vegetation Management Education and Inspection Program for \$500,000.

Without approval of this resolution, the City would not be eligible to participate in the CDBG-MIT PPS program, and as such, would not receive CDBG funding for projects within either the MIT PPS Program. Note that HCD is very specific about the form and format of the resolutions it requests. A sample resolution for the 2017 Tubbs Fire disaster CDBG - MIT PPS Programs is included by way of example as Attachment 1.
