6.1 PUBLIC MEETING - MINOR DESIGN REVIEW FOR A METAL FENCE AND A WOOD FENCE WITH ENTRY GATES AT 730 BENNETT VALLEY ROAD, SANTA ROSA, CA; FILE NO. PLN25-0509

BACKGROUND: The applicant proposes to remove the existing chain-link fence and construct a new 6-foot-tall metal fence and a

6-foot-tall wood fence on the front and corner-side of the subject property. The project is exempt from the California Environmental Quality Act (CEQA).
