

**FIRST AMENDMENT
TO PROFESSIONAL SERVICES AGREEMENT NUMBER F002333
WITH BRYCE DOW-WILLIAMSON**

This First Amendment to Agreement number F002333 dated June 29, 2021 ("Agreement") is made as of this 28th day of November, 2022, by and between the City of Santa Rosa, a municipal corporation ("City"), and Bryce Dow-Williamson ("Consultant").

RECITALS

- A. City and Consultant entered into the Agreement for Consultant to support special events permitting and arts programming.
- B. City and Consultant now desire to amend the Agreement for the purpose of extending the Time of Performance.

AMENDMENT

NOW, THEREFORE, the parties agree to amend the Agreement as follows:

1. Section 12. Time of Performance

The last sentence of Section 12 is amended to read as follows:

"Consultant shall complete all the required services and tasks and complete and tender all deliverables to the reasonable satisfaction of City, not later than June 30, 2023."

All other terms of the Agreement shall remain in full force and effect.
