

CITY OF SANTA ROSA NOTICE OF PUBLIC HEARING

THE CITY COUNCIL WILL REVIEW A REQUEST TO PREZONE PROPERTIES SITUATED ON BARBARA DRIVE, ROBIN WAY, EDDY DRIVE, MOORLAND AVENUE, AND BELLEVUE AVENUE IN PREPARATION TO ANNEX THE AREA INTO SANTA ROSA CITY LIMITS. THIS IS THE FIRST STEP OF A LARGER PROJECT TO PROVIDE WATER SERVICE TO 29 PARCELS, WHICH IS AN AREA WITH KNOWN GROUND WATER CONTAMINATION. THE PROJECT IS BEING INITIATED AND FUNDED BY THE STATE OF CALIFORNIA - FILE NUMBER ANX23-002.

Notice is hereby given that a public hearing will be conducted by the City Council on Tuesday, September 24, 2024, at or after 5:00 P.M. The purpose of the public hearing will be to receive public comments and recommendations prior to the City Council acting on the requested Prezoning application.
