A. Terms and Conditions

1. Agreement. This Order Form and the services to be furnished pursuant to this Order Form are subject to the terms and conditions set forth in the Service Agreement between the County of Sonoma and NEOGOV dated September 7, 2022 (the "County Agreement"). The City's purchase of subscription to the Subscribed Services under this Order Form is facilitated in accordance to the Service Agreement between the City of Santa Rosa and NEOGOV dated August 27, 2017, and its related, subsequent amendments (collectively, the "City Contract"), provided that the County Agreement shall exclusively govern all terms and conditions and supersede any terms set forth in the City Contract. The Effective Date (as defined in the terms and conditions) shall be the date set forth below.
2. Effectiveness & Modification. The Effective Date shall be the Subscription Start Date. This Order Form may not be modified or amended except through a written instrument signed by the parties.
3. Summary of Fees. Listed above is a summary of Fees under this Order Form. Once placed, your order shall be non-cancelable and the sums paid nonrefundable, except as provided in the County Agreement.
4. Order of Precedence. This Order Form shall take precedence in the event of direct conflict with the County Agreement, applicable Schedules, and Service Specifications.


B. Special Conditions (if any).

1. For purposes of this Order Form, the following sentence is added to the second paragraph 15(a) of the County Agreement: "The foregoing limitations set forth in this Section 15(a) shall not apply to claims of any injury to persons or damages to real, tangible property arising out of NEOGOV's gross negligence or willful, gross misconduct."
