4. BOARD BUSINESS

Chair Kincaid re-ordered the agenda to see item 4 prior to item 3.

Chair Kincaid, Design Review Board (DRB), and Chair Meuser, Cultural Heritage Board (CHB), delivered their respective boards statements of purpose.

CHB Chair Meuser and DRB Chair Kincaid reported.

DRB member Kordenbrock abstained from item 8.1 due to professional involvement with the applicant and left the meeting.

8. SCHEDULED ITEMS

8.1* PUBLIC HEARING - THE FLATS AT 528 B STREET - PRELIMINARY DESIGN REVIEW & LANDMARK ALTERATION - FILE NO. PRJ20-005

BACKGROUND: The project proposes to construct a five-story, mixed-use building with commercial space on the ground floor and 24 residential units on the floors above. Parking will be provided in a city-owned parking facility adjacent to the site. The existing building would be demolished. The project requires a Landmark Alteration permit and Design Review. The application was filed by Peter Stanley.

Project Planner: Susie Murray.

Susie Murray, Project Planner, presented.

DRB Vice Chair Hedgpeth joined the meeting at 5:45 p.m.

Staff responded to DRB and CHB member inquiries.

Applicant representatives presented.

Chair Kincaid recessed the meeting.

Chair Kincaid opened the Public Hearing at 7:07 p.m.

Denise Hill spoke in support of the item with height conditions.

Roy Loessin spoke in support of the item with height conditions.

Greg Parker spoke in support of the item with height conditions

Thomas Pope spoke in opposition to the item.

Chair Kincaid closed the Public Hearing at 7:19 p.m.

Applicant representatives responded to Board Member inquiries.

The DRB commented on the item and Chair Kincaid summarized the friendly amendments as:

Consider on all facades where there are tighter reveal areas to change material to the fiber cement, cedar color, to match the soffits.

Consider a smoother CMU material, such as shot-blast smoothness or a limestone block look.

Consider full glazing at office lobby entry.

Consider recessed entry at residential lobby.

Shall eliminate trim around residential Kingspan windows on the west elevation at the north & south corners of the building.

The CHB commented on the item and Chair Meuser summarized the comments as:

Agrees with public comment on design and parking structure. Appreciate the simplicity of the color palate and materials used, but they might not be compatible with the surrounding neighborhood, and that three to four stories is preferred by several board members, while others justified five because the project is a non-contributor.

After discussion with the boards, Staff took a recess.

Bill Rose, Deputy Director Planning, clarified the denial / board consensus process.

The Applicants addressed the board.

The Cultural Heritage Board discussed the Land Mark Alteration permit
